# Frequently Asked Questions About Student Records & Immigration

## **1. What student enrollment information does the Fullerton School District collect?**

The Fullerton School District only collects essential information to enroll students in our schools which includes:

- Proof of residence or employment in the Fullerton School District boundaries or service areas.
- NO Social Security Numbers or Legal Residency Information.
- NO family immigration status information.

## **2. What are the procedures for collecting documentation for age and place of birth?**

- Bring your child's documentation to the school office.
- The office will verify the child's birthdate and place of birth documentation (birth certificate, baptism certificate, passport, etc.).
- You will be asked if you would prefer to have copies of the documentation placed in your child's cumulative record or if you would prefer to complete the Affidavit for Proof of Legal Name and Age of Minor form.

## **3. What information do the Fullerton School District After School Program Providers collect?**

- After School Providers follow these same guidelines as the District.

## **4. What if a Federal Agent comes to the School Office requesting to see students or documentation?**

- Federal policy designates schools as "sensitive locations" where immigration action by Federal authorities is to be avoided. Federal Agents can not come on campus except under special circumstances.
- If a Federal agent comes on campus, they will immediately be referred to the principal, who will contact the Superintendent.
- NO student information is released without a court order.
- NO immigration status is released unless there is a warrant or subpoena from a Federal Magistrate Judge.

## **5. What if my child's cumulative record already contains copies of age and birth documents?**

- You may have these documents removed at your request by going to the school office, completing an Affidavit, and having the copy of the document removed from the cumulative record and returned to you.

## **6. Will my children be safe at school?**

The safety and security of our students is our top priority.

- All students are provided with a school environment free from:
  - Bullying
  - Intimidation
  - Discrimination
- All adults on campus ensure that students are provided with:
  - A positive approach to behavior with fair and equitable rules and consequences.
  - A climate of respect for self and others.
  - A safe environment.

## **7. Who can pick my child up from school if I am not able to?**

- We encourage all parents to have multiple individuals listed on their student's Emergency Information Card who are authorized to pick up their child in case of an emergency. Make sure your Emergency Information Card is up to date in Power School.

**All children have the right to fully participate in all programs and receive a high quality education in an appropriate learning environment with sufficient resources.**
