# What is a School wide Title I Program?



- Title I is one part of the Every Student Succeeds Act (ESSA) reauthorized in 2016 .
- A schoolwide program is a comprehensive reform strategy designed to upgrade the entire educational program; its primary goal is to ensure that all students, particularly those who are low-achieving, demonstrate proficient and advanced levels of achievement on State academic achievement standards.

# How does a school qualify for a School wide Title I Program?



- Title I school may operate as a schoolwide program only if a minimum of 40 percent of the students in the school, or residing in the attendance area served by the school, are from low-income families (participating in National School Lunch Program (NSLP)).
- Our school has 82.58% percentage of families participating in the NSLP.

# What does the Title I Program look like at our school?



- Structures are in place to support at-risk students and monitor student learning:
  - *Tutoring, interventions, additional staff, language support, additional documentation, parental engagement, capacity building, ...*
- Title I funds support improved student academic achievement by:
  - *Social Service Assistant, Instructional Aides, Bi-Lingual Office Staff, Translated Materials, Response to Intervention Teacher,*

# How are parents involved in the Single Plan for Student Achievement?



- Elected parents participate in the School Site Council (SSC).
- The SSC is involved in the development of the Single Plan for Student Achievement (SPSA), as well as the annual evaluation of the SPSA and monitoring the implementation of the SPSA actions toward achieving the School goals.
- The SPSA describes the Title I Program at our school.
