**Review Consolidated Application:** Director of Educational Services Sung Chi went over how in addition to the state funding that Jenel Lao shared, the District also receives federal funding through four different sources. The funds that specifically support the English Learners come from the Federal Title III funds as well as the LCFF supplemental funds that Jenel had mentioned through reviewing the LCAP.

**Partners for Wellness-Vaping & Tobacco:** Paige Petrus-Medina, Health Educator from Partners4Wellness formerly NCADD-OC gave a presentation on Vaping & Tobacco. She went over Tobacco/ Vapes, Nicotine Health, how vaping affects the youth, trends with COVID-19 and Vape use.
