Superintendent's Report

Dr. McCune thanked Lynn Thornley for her excellent leadership this year as Board President and congratulated Hilda Sugarman as the new Board President for 2004. Superintendent McCune reported: the Coordinated Compliance Review process began today for Richman School and Nicolas Junior High School; attended the Fullerton Police Department dedication last week at their new facility; five of the District's schools (Acacia, Golden Hill, Raymond, Laguna Road, and Fern Drive) have applied for California Distinguished School; Parks Junior High School has been invited to apply for National Blue Ribbon School; attended farewell celebration for Ana Stover; congratulated Parks Junior High School 7th grade student Nicole Lee on winning the Lions Club National Peace Poster Contest, at the local level as well as State levels (California and Nevada), and is moving on to compete at the National level; attended Star Power Grant awards yesterday congratulating Nicolas Junior High as being the recipient of seven grants; the local Rotary Main is providing signs at all of the District's schools that say "Drive Carefully – Protect Our Children" at no cost to the District.

COMMUNITY RELATIONS

<u>Uniform Complaint Procedures Concerning Educational Programs</u>

The Board of Trustees recognizes that the District has primary responsibility for ensuring that it complies with state and federal laws and regulations governing educational programs. The District shall investigate and seek to resolve complaints at the local level. The District shall follow uniform complaint procedures pursuant to state regulations when addressing complaints alleging unlawful discrimination or failure to comply with the law in consolidated categorical programs, child care and development programs, child nutrition programs and special education programs.

Complaints concerning special education programs shall be addressed in accordance with the regulations and procedures set forth in Federal Law and the State Education Code which are included in the North Orange County Special Education Local Plan. The Uniform Complaint procedures are included in the Parents Rights which are provided to the parent/guardian during the referral and Individualized Education Plan processes.

The Board of Trustees prohibits retaliation in any form for the filing of the complaint, the reporting of instances of discrimination, or for participation in complaint procedures. Such participation shall not in any way affect the status, grades, or work assignments of the complainant.

The Board of Trustees acknowledges and respects student and employee rights to privacy. Complaints shall be investigated in a manner that protects these rights. The identity of any complainant shall be kept as confidential as appropriate.

The Superintendent or designee shall ensure that employees designated to receive and investigate complaints are knowledgeable about the laws and programs for which they are responsible. Such employees may have access to legal counsel as determined by the Superintendent or designee.

The Board designates the Assistant Superintendent of Administrative Services *Personnel Services*, 1401 West Valencia Drive, Fullerton, California 92833, (714) 447-7450 as the District's compliance officer to receive complaints, direct investigation of complaints, maintain records of complaints and subsequent related actions, and ensure District compliance with law.

Notifications

The Superintendent or designee shall meet the notification requirements of the Code of Regulations, Title 5, Section 4622, including the annual dissemination of district complaint procedures and information about available appeals, civil law remedies, and conditions under which the complaint may be taken directly to the California Department of Education. This notification must be (a) in English; (b) in the primary language of the students when 15% or more of the students in a school speak that language; or (c) in the mode of communication of the recipient of the notice.

SUBJECT: REVIEW REVISIONS TO BOARD POLICY 5116 STUDENTS, INTRADISTRICT

TRANSFERS

<u>Background:</u> These revisions will remove from policy language the requirement that open

enrollment occur on a specific date as well as other unnecessary language. This will make the policy more reflective of current practices and will provide flexibility in the scheduling of the open enrollment period while maintaining the integrity of the process and access to choice for all parents. It will allow the District some needed flexibility as it works with boundary adjustments and related matters that may

impact the open enrollment and/or transfer processes.

<u>Funding</u>: No added costs are anticipated due to these policy revisions.

Recommendation: Review revisions to Board Policy 5116 Students, Intradistrict Transfers.

Intradistrict Transfers

I. PURPOSE AND INTENT

The Board of Trustees of the Fullerton School District (FSD) endorses the neighborhood public school concept. However, the Board recognizes that parents may wish to choose a school of attendance other than the assigned school. The Board of Trustees therefore believes that parental choice among the District's public schools should be included as an integral feature of a well-rounded educational environment.

Home school attendance areas are established to optimize the use of existing facilities and to avoid crowded conditions. However, **R**equests for intradistrict transfers may be made for reasons of personal preference based on the needs of the family or child, after school activities, desire for enrollment in a specialized program, or the instructional philosophy and approach used by a particular school. The parent/guardian of each schoolage child who is a resident of the District may select a school the child shall attend. This selection will be dependent upon space available at the school of choice and upon the ability of the parent/guardian to arrange transportation to that school. It may be made irrespective of the particular location of his or her residence **with**in the District. The Board of Trustees retains the authority to maintain appropriate racial and ethnic balances among District schools.

This policy shall be reviewed annually by the Board of Trustees.

II. CRITERIA FOR SCHOOL PLACEMENT

The Superintendent or designee shall determine the capacity of each District school using existing facilities and establish a random, unbiased selection process for the admission of students from outside a school's attendance area when the requests for admission exceed the school/grade level's capacity. No new facilities or programs will be added based on new transfer students. If the capacity of the grade level would be exceeded by admitting all of the students requesting intradistrict transfers, a random lottery will be held on the eleventh school day of March following the start of the Open Enrollment period to determine which students will be admitted. All Intradistrict transfer applications received after the tenth school day of March close of the ten day Open Enrollment period will be placed on the waiting list behind students who were not admitted when the lottery was held. This waiting list shall be maintained through the twentieth day of the following school year. The Superintendent or designee retains the final authority in all student placement decisions.
