- Background: Curriculum Calibration is the DataWorks Educational Research process where actual student work from each participating Title I school is collected from teachers over a one-week period of time and then measured against the California State Content Standards. Teachers then get information back as to whether the assignments are indeed matched to the rigor of the grade level standard. Curriculum Calibration provides a working framework and feedback to improve the alignment of the "taught" curriculum.

DataWorks provides analysis of student work and a follow-up training for each school site. The process includes collection, calibration, and an on-site presentation of results. DataWorks provides training in the standards and solid baseline data regarding a school's actual alignment to standards.

The following Title I schools will participate in the Curriculum Calibration process: Commonwealth, Maple, Orangethorpe, Pacific Drive, Valencia Park Primary and Intermediate, and Woodcrest.

<u>Funding</u>: The fee is \$5,000 per participating Title I school and is to be paid through District Title I budget #0121252101-4805.

In addition, Beechwood staff and District personnel have attended an IB orientation meeting. Two community parent information meetings have been held to inform parents about the program. Implementation of the Middle Year Program is a 4-5 year process before final authorization.

A recent Parent Interest Survey was sent to all 5<sup>th</sup>/6<sup>th</sup> graders in the District. At this point in time, there are 23 students, not from the Beechwood attendance area, interested in 6<sup>th</sup>grade, with all 23 of those students interested in IBMYP. Currently, at Beechwood there are two classes of 5th grade students. Of these two classrooms, 50 students are expected to remain in the IBMYP classes. That makes over two classes of 6<sup>th</sup> graders identified for IBMYP at Beechwood in the 2005-2006 school year.

There are 23 students, not from the Beechwood attendance area, interested in attending 7<sup>th</sup>grade at Beechwood School in the fall of 2005. Of those 23 students, all 23 are interested in IBMYP. Currently, at Beechwood there is one 6<sup>th</sup> grade class of 34 students, of which 17-20 indicate interest in IBMYP. This is approximately 40 potential 7<sup>th</sup> graders for IBMYP at Beechwood in the 2005-2006 school year. It is anticipated that this number will grow as word spreads that Beechwood is designated a K-8 IBMYP school.

Although Beechwood has been approved to move to a K-8 format, it was in anticipation of additional students electing to attend Beechwood. In order to provide even a minimal typical Middle School Program, there is a need for at least two full classes at grades 6, 7 and 8. Without this there cannot be an appropriate elective program and it does not warrant the anticipated capital improvements to accommodate the addition of grades 7 and 8.

Because IB is a unique program it is anticipated that it will attract students throughout the area much as Troy High School has.

	To date, 13 siblings of potential 6 <sup>th</sup> and 7 <sup>th</sup> graders, not currently attending Beechwood, have indicated an interest in attending Beechwood in the fall of 2005. This is anticipated to grow as the IBMYP grows.
Funding:	General Fund (01) and Capital Facilities Fund (25).
	Staff Development: Application fees and staff development costs of approximately \$14,300.00 for the 2005-2006 school year and approximately \$16,500.00 for the 2006-2007 school year will be paid from the General Fund.
	<u>Facilities:</u> The projected related facility cost is basically a science building at approximately \$300,000 allowing a 5% contingency paid from developer fees.
	<u>Staffing:</u> For 2005-2006, depending on whether there are two or three 6 <sup>th</sup> grade classes and/or 7 <sup>th</sup> grade classes, extra staffing costs could range from .3 – 2.0 FTEs. For 2006-2007, depending on whether there are two or three 6 <sup>th</sup> , 7 <sup>th</sup> and/or 8 <sup>th</sup> grade classes, extra staffing costs could range from .5 to 2.5 FTEs. The average cost of an FTE is \$60,000.00. The accommodation of a Junior High School band is not included in the above projections. P.E. facilities are also not included just as Fisler does not have P.E. facilities.
Recommendation:	Approve Beechwood School to move forward with the planning/implementation of the International Baccalaureate Program for 6 <sup>th</sup> and 7 <sup>th</sup> grades for the 2005-06 school year and 8 <sup>th</sup> grade for the 2006-07 school year. Implementation is a 4-5 year process.

- Background: The Board of Trustees voted in 2000-2001 that the Fullerton School District would match the Fullerton Joint Union High School District's calendar until the 2003-2004 school year. The decision was based upon the calendar being more closely aligned with the high school district's needs rather than the K-8 needs for semester breaks and starting prior to Labor Day. The start prior to Labor Day has cost Fullerton School District ongoing base revenue dollars through reduced ADA for the last four years. We are proposing in these difficult budgetary times that we begin our pupil attendance calendar after Labor Day.

The high school district set their summer school schedule without consulting the Fullerton School District for 2005-2006, and it appears that our students will not align with summer school offerings for regular and special needs students. Some modifications will be made for eighth grade students in the 2005/2006 school year to accommodate attendance to the high school summer school program. It is therefore recommended that we begin school on Tuesday after Labor Day and forego the proposed President's Week break, which would have provided an entire week off including both President's holidays, until all interested parties can sit down and discuss options for the 2006-2007 school year. The proposed calendar is attached.

#### RESOLUTION OF FULLERTON SCHOOL DISTRICT APPROVING THE CONSTRUCTION OF ADDITIONAL PARKING FACILITIES AT RICHMAN SCHOOL AND MAKING CERTAIN FINDINGS IN CONJUNCTION THEREWITH

WHEREAS, the Fullerton School District ("District") will be constructing (by this summer) parking facilities on the north side of the front of Richman Elementary School, located at 700 South Richman Avenue in the City of Fullerton, California ("Richman School"); and

WHEREAS, the existing on-site parking is insufficient to accommodate the staff working at Richman School, and therefore a portion of Richman School's teaching and administrative staff have been parking on the street adjacent to the school; and

WHEREAS, the District desires to construct additional on-site parking on an approximately 12,000 square foot portion of the school site adjacent to the existing on-site parking.

WHEREAS, the California Environmental Quality Act, Public Resources Code sections 21000 et seq. ("CEQA"), and its implementing guidelines, Title 14 of the California Code of Regulations, Sections 15000 et seq. (the "Guidelines") provide that certain activities of school districts are exempt from CEQA, including Section 15314 of the Guidelines, which exempts minor additions to existing schools within existing school grounds where the addition does not increase original student capacity by more than 25% or ten classrooms, whichever is less; and

WHEREAS, Guidelines Sections 15301 and 15303 also exempt construction and location of new, small facilities or structures, as well as alterations to existing facilities, including, without limitation accessory structures and improvements including garages, carports, patios, swimming pools, and fences; and

WHEREAS, Guidelines Section 15311 exempts from CEQA the construction, or placement of minor structures accessory to existing institutional facilities, including but not limited to small parking lots;

NOW THEREFORE, the Fullerton School District Board of Trustees hereby finds and resolves as follows:

1. The construction of up to ten (10) additional parking spaces at Richman School is hereby approved. The approximately 12,000 square feet will provide for around 30 or 40 parking places.

2. The action of the District pursuant to this resolution is exempt from the requirements of CEQA pursuant to CEQA Guidelines Sections 15314, 15301, 15303, and 15311.

3. The Secretary of the Board is hereby authorized to file with the Clerk of the County of Orange, and with the State of California Office of Planning and Research, State Clearinghouse, a notice of exemption in the form attached hereto as Exhibit "A", and to pay any filing or administrative fees associated therewith.
