Administrators have two years to complete the

Administrators (ACSA). The ACSA program will include training on vision and culture,

fiscal management, instructional leadership and technology.

Rationale: The Administrator Training Program ensures the leadership, infrastructure, and support

for full implementation of effective instructional programs to improve student

achievement.

<u>Funding</u>: The cost for Modules 2 and 3 is \$700.00 per participant, per module, for a total fee of

\$14,000.00. Five participants will be paid from AB430 Administrator Training grant funding budget (#325) in the amount of \$5,000.00 and Title II Teacher/Principal Staff Development grant funding (#217) in the amount of \$2,000.00. Five additional participants will be paid from High Priority School Grant funding budget (#210) in the amount of \$1,400.00 and Title II Teacher/Principal Staff Development grant funding

(#217) in the amount of \$5,600.00.

# MEMORANDUM OF UNDERSTANDING BETWEEN THE ASSOCIATION OF CALIFORNIA SCHOOL ADMINISTRATORS AND FULLERTON ELEMENTARY SCHOOL DISTRICT

#### INTRODUCTION

The Association of California School Administrators is dedicated to the professional learning and support of school leaders. AB75 (The Principals Training Act) was signed into law in 2001. It was subsequently reauthorized as AB430 in 2005. This combined legislation was supported by ACSA in the belief that these initiatives provide increased opportunities to ensure that school administrators have the skills and knowledge needed to succeed.

ACSA applied for and was approved by the State Board of Education as an AB 430 provider for Module 2 (Leadership and Management for Instructional Improvement) and Module 3 (Instructional Technology to Improve Pupil Performance).

This Memorandum of Understanding is designed to identify roles and responsibilities for each party.

#### A. ACSA will provide:

- 1. The content and approved AB430 program for Module 2 and 3 and training materials for each participant. ACSA will provide an implementation guide to facilitate the local coordination and completion of AB 430 program requirements.
- 2. An ACSA Educational Services Executive will coordinate the delivery of training based upon mutual agreement with the Fullerton Elementary School District AB 430 coordinator. The ACSA Executive will meet with Fullerton Elementary School District officials to customize the training program using some or all of the following:
  - Inclusion of the district vision, mission, goals and improvement priorities, investments and development efforts in the School Plan for Student Achievement
  - Analysis of local measures of student learning
  - Use of the district's priorities and expectations for the school site
  - Use of district selected instructional materials
  - Use of the databases and student information systems used in the district
  - Understanding of district policies regarding human resources
  - Deepening of the curriculum based on the experiences, current competencies and prior training of the principals and vice principals in the district
- 3. For Module 2, ACSA approved trainers will provide 20 hours of Institute training on the following topics and dates:
  - Topics
    - Vision and Culture (6.5 hours)
    - Fiscal Management (3.5 hours)
    - People and Performance (6.5 hours)
    - Knowledge and Data (3.5 hours)
  - Dates to be scheduled during Spring and Fall of 2008 in conjunction with the Placentia-Yorba Linda Unified School District
- 4. For Module 3, ACSA approved trainers will provide 20 hours of Institute training on instructional leadership and technology on the following dates:
  - Dates to be scheduled during Spring and Fall of 2008 in conjunction with the Placentia-Yorba Linda Unified School District
- 5. ACSA will provide a practicum guide for each participant to develop his/her practicum. The Practicum will consist of 20 hours each for Modules 2 and 3. The guide will include suggestions for follow-up activities which may support the completion of the Practicum.
- B. The Fullerton Elementary School District will contract for a minimum of 10 participants and appoint an AB430 Coordinator who will:

**Training Logistics** 

- 1. Identify participants who will be in the training.
- 2. Arrange for the billing of individual participants and coordinate the lump sum payments to ACSA per this MOU.
- 3. Provide information on each participant, including name, school, position and years of experience.
- 4. Provide access to the district Curriculum and Instruction administrator and Information Systems specialist and other appropriate staff.
- 5. Assist with gathering needed district/agency documents and policies to support the training.

#### **Practicum and Reporting**

- 6. Work collaboratively with ACSA to support participants with the development, completion, and approval of each participant's follow-up practicum plan (20 hours per module).
- Coordinate and provide support to participants in the implementation, completion, and certification of the Practicum for each principal and assistant principal including collecting, and keeping on file, all completed practicum materials for each participant.
- 8. Work collaboratively with ACSA to gather data and provide required reports to the California Department of Education.
- 9. Identify any attendance problems and make-up needs for individual participants.

#### C. Compensation

The Fullerton Elementary School District (LEA) will pay ACSA at the rate of \$700.00 per participant per module. ACSA will invoice the district (LEA) according to the following schedule:

- 1/3 of the fee due at the signing of the MOU and the determination of the number of participants.
- 1/3 due after the completion of the 20 hours of training
- 1/3 due after a pre-designated period for the completion of the 20 hours of practicum

The Fullerton Elementary School District will provide \$1,000.00 in local matching funds for each principal trained and up to \$500.00 for each vice principal trained, based on overall participation in the program. Any combination of local, federal, or private resources or contributions may be used for the matching fund contribution. In-kind contributions may not be used for the local agency's match. No portion of the matching funds will be collected or monitored by ACSA.

#### D. Duration and schedule

The agreement will be in effect from February 26, 2008 through June 30, 2009. Participants will complete the Institute training and the Practicum within a two year period beginning July 1 of participants' AB 430 grant period.

# FULLERTON SCHOOL DISTRICT ADMINISTRATOR TRAINING PROGRAM

This AGREEMENT is hereby made and entered into this 31st day of January, 2008, by and between the Orange County Superintendent of Schools, 200 Kalmus Drive, Costa Mesa, California 92626, hereinafter referred to as SUPERINTENDENT, maintaining the Administrator Training Program, and Fullerton School District, 1401 West Valencia Drive, Fullerton, California 92833, hereinafter referred to as DISTRICT. SUPERINTENDENT and DISTRICT shall be collectively referred to as the Parties.

- 1.0 BASIS OF AGREEMENT. SUPERINTENDENT, as a State Board of Education (SBE) approved AB 430 Training Provider will provide training for DISTRICT administrators focused on building administrators' leadership skills and capacity to serve effectively in their critical and complex roles. The goal of AB 430 is to develop school site and district administrators who come from a variety of contexts and challenging environments, which are able to establish sound and clear instructional goals, who collaboratively develop data-driven instructional strategies, and who lead a school through powerful instructional change.
- 2.0 TERM. This AGREEMENT shall be in full force and effect for the period commencing February 8, 2008 and ending on February 8, 2010, subject to termination as set forth in this AGREEMENT.
- 3.0 <u>TRAINING</u>. SUPERINTENDENT as a Training Provider shall design a program to fit the needs of DISTRICT and its schools and administrators. Through collaboration with the DISTRICT,

SUPERINTENDENT shall individualize and differentiate its training levels of administrator address various program options to and prior training. experiences, current competencies, SUPERINTENDENT will also work in collaboration with DISTRICT and its partners (institutions of higher education and other educational entities) to plan and provide high quality, intensive, follow-up trainings. SUPERINTENDENT shall provide training in one or more of the following modules:

- 3.1 Module 1: Leadership and Support of Student Instructional Programs. (40 hours of training and 40 hours of Practicum\*)
- 4. DISTRICT'S RESPONSIBILITIES. DISTRICT agrees to the following:
  - 4.1 Identify an administrator and liaison to work closely with SUPERINTENDENT to create a schedule for professional development that meets the DISTRICT'S training needs according to state criteria.
  - 4.2 Provide the names of the administrators that will be participating in the AB 430 Administrator Training Program. In addition, provide the number of administrators, name of the school, and which training module each will be attending.
  - 4.3 Ensure that all administrators understand their responsibilities and the requirements of the AB 430 Administrator Training Program.
- 5.0 <u>TRAINING COSTS</u>. The costs for the AB 430 Administrator Training Program modules and practicum are as follows:

• AB 430 Module 1 (40 hours training + 40 hours practicum): \$2,000.00 Per Participant.

#### 6.0 PAYMENT.

A. DISTRICT agrees to pay SUPERINTENDENT the total sum not to exceed Twenty-four thousand dollars (\$24,000.00) for services satisfactorily rendered pursuant to Section 3.0 of this AGREEMENT. Payment shall be made to SUPERINTENDENT periodically, upon performance of services and receipt and approval of an invoice in triplicate. Payment shall be mailed to: Orange County Superintendent of Schools, Attn: Accounting Manager, 200 Kalmus Drive, P.O. Box 9050, Costa Mesa, California 92628-9050, or at such other place as SUPERINTENDENT may designate in writing.

- B. DISTRICT may withhold or delay any payment should SUPERINTENDENT fail to comply with any of the provisions set forth in this AGREEMENT.
- C. The obligation of DISTRICT under this AGREEMENT is contingent upon the availability of funds furnished by the State of California. In the event that such funding is terminated or reduced, this AGREEMENT may be terminated and DISTRICT'S fiscal obligations hereunder shall be limited to a pro rated amount of funding actually received by the DISTRICT under the grant. DISTRICT shall provide SUPERINTENDENT written notification of such termination. Notice shall be deemed given when received by the SUPERINTENDENT or no later than three (3) days after the day of mailing, whichever is sooner.

<u>Background:</u> This agreement is for the continuation of services provided by the Boys and

Girls Clubs of Fullerton originally funded for 175 students. However, the District has been able to maintain 184 students at Valencia Park and Commonwealth schools. Accordingly, the grant that funds the program will increase student allocation per school year to reflect increase attendance. This revised agreement reflects an increase of 175 to 184 students served per day at Commonwealth and Valencia Park schools. The increase in funds is

retroactive to July 1, 2006 through June 30, 2009. The amount of \$10,935.00

per school year will be adjusted to reflect the correct government rate.

Rationale: The Boys and Girls Clubs of Fullerton collaborates with the District in providing

after school academic support and enrichment experiences funded by the After School Education and Safety Grant. The increase in the number of students served reflects a change in the program allocation awarded by the California

Department of Education.

Funding: Payment solely from Proposition 49, After School Education and Safety Grant.

The amended grant amount of \$223,560.00 reflects an increase of \$10,935.00

per school year commencing July 1, 2006 through June 30, 2009.

#### INDEPENDENT CONTRACTOR AGREEMENT

(Amendment February 26, 2008 Retroactive to July 1, 2006)

This agreement is hereby entered into between the Fullerton School District, hereinafter referred to as "DISTRICT", and **Boys and Girls Clubs of Fullerton, 348 W. Commonwealth Ave., Fullerton, California 92832, 714.871.1391** hereinafter referred to as "CONTRACTOR".

WHEREAS, DISTRICT is authorized by Section 53060 of the California Government Code to contract with and employ any persons for the furnishing of special services and advice in financial, economic, accounting, engineering, legal or administrative matters, if such persons are specially trained and experienced and competent to perform the special services required; and

WHEREAS, DISTRICT is in need of such special services and advice; and WHEREAS, CONTRACTOR is specially trained and experienced and competent to perform the special services required by the DISTRICT and such services are needed on a limited basis;

NOW, THEREFORE, the parties agree as follows:

#### 1. SERVICES TO BE PROVIDED BY CONTRACTOR:

The Boys and Girls Clubs of Fullerton will provide an after school program that is in compliance with the After School Education and Safety Grant. A copy of the specific grant requirements will be provided to each grantee. Grant requirements include a three-hour program day (180 days) with a minimum of 1 hour devoted solely for homework/academic support and 2 hours of enrichment activities. The funding amount reflects a maximum of 84 participants at

Commonwealth and 100 participants at Valencia Park. The maximum adult/student ratio is not to exceed 1/20. In addition, funding is based on daily attendance and accurate records are to be maintained at each program site. Site supervisors will implement appropriate student sign in and out procedures. The program is required to maintain an inventory with documentation of all supplies purchased with grant funds. Program budgets must designate 85% of funds to direct services and 15% to indirect/administrative costs. This contract is effective July 1, 2006.

#### 2. DISTRICT HAS THE RIGHT TO ESTABLISH PROGRAM ASSESSED:

#### A) Term:

CONTRACTOR shall commence providing services under this agreement on a date mutually agreed upon by DISTRICT and CONTRACTOR in compliance with timeline identified by the California Department of Education and will diligently perform as required and complete performance by a date not to exceed 36 months from the original start date of July 1, 2006 - June 30, 2009.

#### B) <u>Compensation</u>:

DISTRICT agrees to pay CONTRACTOR for services satisfactorily rendered pursuant to this AGREEMENT a total fee of \$223,560.00 annually (184 students at \$6.75 per day for 180 operating days), based on maintaining 85% daily attendance.

Contract increase is \$10,935 for each school year July 1, 2006 through June 30, 2009. DISTRICT shall pay CONTRACTOR according to the following terms and conditions: Submission of monthly invoice to the Childcare Services Office with an attached copy of attendance. Payments are distributed in monthly equal sums.

#### C) <u>Expenses</u>:

DISTRICT shall not be liable to CONTRACTOR for any costs or expenses incurred by CONTRACTOR in performing services for DISTRICT.

#### D) <u>Independent Contractor</u>:

CONTRACTOR, in performance of this AGREEMENT, shall be and act as an independent contractor. Contractor understands and agrees that he/she and all of his/her employees shall not be considered officers, employees or agents of the DISTRICT and are not entitled to benefits of any kind or nature to which DISTRICT employees are normally entitled including, but not limited to State Unemployment Compensation or Worker's Compensation. CONTRACTOR assumes the full responsibility for payment of all federal, state and local taxes or contributions, including unemployment insurance, social security, and income taxes with respect to CONTRACTOR'S employees. CONTRACTOR will provide DISTRICT with proof that CONTRACTOR has provided any employee working under the terms of this grant with appropriate Worker's Compensation and/or State Unemployment Compensation. In addition, CONTRACTOR shall provide proof that all employees have been fingerprinted.

#### E) <u>Materials</u>:

CONTRACTOR shall furnish, at his/her own Expense, all labor, materials, equipment, supplies, and other items necessary to complete the services to be provided pursuant to this AGREEMENT. This includes, but is not limited to: craft supplies, music CD's, tapes, sound equipment, nature study materials, sports equipment, games, field trip entrance fees, transportation for field trips, special presentations. CONTRACTOR'S services will be performed, funding obtained.

reports and recommendations prepared in accordance with generally and currently accepted principles and practices of his/her profession.

#### F) Originality of Services:

CONTRACTOR agrees that all technologies, formulae, procedures, processes, methods, writings, ideas, dialogue, compositions, records, teleplays, and video productions prepared for, written for, submitted to DISTRICT and/or used in connection with this AGREEMENT, shall be wholly original to CONTRACTOR and shall not be copied in whole or part from any other source, except that submitted to CONTRACTOR by DISTRICT as a basis for such services.

#### G) Copyright/Trademark/Patent:

CONTRACTOR understands and agrees that all matters produced under this AGREEMENT shall become the property of DISTRICT and cannot be used without DISTRICT'S express written consent. DISTRICT, shall have all right, title and interest in said matters, including the right to secure and maintain the copyright, trademark, and/or patent of said matter on the name of DISTRICT. CONTRACTOR consents to use of CONTRACTOR'S name in conjunction with the sale, use, performance, and distribution of the materials for any purpose and in any medium.

#### H) <u>Termination</u>:

DISTRICT may, at any time, with or without reason, terminate this AGREEMENT for cause, and compensate CONTRACTOR only for services satisfactorily rendered to the date of termination. Written notice by DISTRICT shall be deemed given when received by CONTRACTOR or not later than three days after the day of mailing, whichever is sooner.

DISTRICT may terminate this AGREEMENT upon giving of written notice of intention to terminate for cause. Cause shall include: (a) material violation of this AGREEMENT

by CONTRACTOR; or (b) any act by CONTRACTOR exposing DISTRICT to liability to others for personal injury or property damage; or inability to properly perform services, or CONTRACTOR is adjudged bankrupt, CONTRACTOR makes a general assignment for the benefit of creditors or a receiver is appointed on account of CONTRACTOR'S insolvency. Written notice by DISTRICT shall contain the reasons for such intention to terminate and unless within thirty (30) days after service of such notice the condition or violation shall cease, or satisfactory arrangements for the correction there if be made, this AGREEMENT shall upon the expiration of the thirty (30) days cease and terminate. In the event of such termination, DISTRICT may secure the required services from another contractor. If the cost to DISTRICT exceeds the cost of providing the services pursuant to this AGREEMENT, the excess cost shall be charged to and collected from CONTRACTOR. The foregoing provisions are in addition to and not a limitation of any other rights or remedies available to DISTRICT. Written notice by DISTRICT shall be deemed given when received by the other party, or no later than three days after the day of mailing, whichever is sooner.

#### I) <u>Hold Harmless</u>:

CONTRACTOR agrees to and does hereby indemnify, hold harmless and defend the DISTRICT and its Governing Board, officers, employees and agents from every claim or demand made and every liability, loss, damage or expenses, of any nature whatsoever, which may be incurred by reason of:

(a) Liability for damages: (1) death or bodily injury to person; (2) injury or, loss or theft of property; or (3) any other loss, damage or expense arising out of (1) or (2) above, sustained by the CONTRACTOR or any person, firm or corporation employed by CONTRACTOR, either directly or by independent contract, upon or in connection with the services called for in this AGREEMENT, however caused, except for liability

for damages referred to above which result from the sole negligence or willful misconduct of DISTRICT or its officers, employees, or agents;

(b) Any injury to or death of any persons, including DISTRICT or its officers, employees and agents or damage to or loss of any property caused by any act, neglect, default, or omission of CONTRACTOR, or any person, firm or corporation employed by CONTRACTOR either directly or by independent contract, arising out of or in any way connected with the services covered by this AGREEMENT, whether said injury or damage occurs either on or off DISTRICT'S property, except for liability for damages which result from the sole negligence or willful misconduct of DISTRICT or its officers, employees or agents.

#### J) <u>Insurance</u>:

Pursuant to Section I, CONTRACTOR agrees to carry a comprehensive general and automobile liability insurance with limits of Three Hundred Thousand and One Hundred Thousand Dollars (\$300,000 and \$100,000) per occurrence combined single limit for bodily injury and property damage in a form mutually acceptable to both parties to protect CONTRACTOR and DISTRICT against liability or claims of liability which may arise out of this AGREEMENT. In addition, CONTRACTOR agrees to provide an endorsement to this policy (no later than 15 days after dated signing of AGREEMENT) stating, "Such insurance as is afforded by this policy shall be primary and any insurance carried by DISTRICT shall be excess and noncontributory."

CONTRACTOR shall provide DISTRICT with certificates of insurance evidencing all coverage and endorsements required hereunder including a thirty (30) day written notice of cancellation or reduction in coverage. CONTRACTOR agrees to name DISTRICT and its officers, agents and employees as additional insured under said policy.

#### K) Assignment:

The obligations of the CONTRACTOR pursuant to this AGREEMENT shall not be assigned by the CONTRACTOR.

#### L) Compliance with Applicable Laws:

The service(s) completed herein must meet the approval of the DISTRICT and shall be subject to the DISTRICT'S general right of inspection to secure the satisfactory completion thereof. CONTRACTOR agrees to comply with all federal, state, and local laws, rules, regulations and ordinances that are now or may in the future become applicable to CONTRACTOR, CONTRACTOR'S business, equipment and personnel engaged in operations covered by this AGREEMENT or accruing out of the performance of such operations.

#### M) Permits/Licenses:

CONTRACTOR and all CONTRACTOR'S employees or agents shall secure and maintain in force such permits and licenses as are required by law in connection with the furnishing of services pursuant to this AGREEMENT.

#### N) <u>Employment With Public Agency</u>:

CONTRACTOR, if any employee of another public agency, agrees that CONTRACTOR will not receive salary or remuneration, other than vacation pay, as an employee of another public agency for the actual time in which services are actually being performed pursuant to this AGREEMENT.

#### O) Entire Agreement/Amendment:

This AGREEMENT and any exhibits attached hereto constitute the entire agreement among the parties to it and supersede any prior contemporaneous understanding or agreement with respect to the services contemplated, and may be amended only by a written amendment executed by both parties to the AGREEMENT.

#### P) <u>Affirmative Action Employment</u>:

CONTRACTOR agrees that it will not engage in unlawful discrimination in employment of persons because of race, color, religious creed, national origin, ancestry, physical handicap, medical condition, marital status, or sex of such persons.

#### Q) Non Waiver:

The failure of DISTRICT or CONTRACTOR to seek redress for violation of, to insist upon, the strict performance of any term or condition of this AGREEMENT, shall not be deemed a waiver by that party of such term or condition or prevent a subsequent similar act from again constituting a violation of such term or condition.

#### R) <u>Notice</u>:

All notices or demands to be given under this AGREEMENT by either party to the other, shall be in writing and given either by (a) personal server or (b) by U.S. mail, mailed either by registered or certified mail, return receipt requested, with postage prepaid. Service shall be considered given when received if personally serviced or mailed on the third day and after deposit in any U.S. Post Office. The address to which notices or demands may be given by either party may be changed by written notice given in accordance with the notice provisions of this section. At the date of this AGREEMENT the addresses of the parties are as follows:

# FULLERTON SCHOOL DISTRICT FOR THE PROVISION OF SERVICES

This FIRST AMENDMENT TO AGREEMENT ("First Amendment") is entered into as of the 6<sup>th</sup> day of December, 2007 ("Date of Amendment"), which date is enumerated for the purpose of reference only, by and between the CHILDREN AND FAMILIES COMMISSION OF ORANGE COUNTY, a public body and legal public entity ("COMMISSION") and FULLERTON SCHOOL DISTRICT, a school district organized and existing under the laws of the State of California ("CONTRACTOR"). The Original Agreement and this First Amendment are and shall continue to be administered by the Executive Director of COMMISSION or his/her authorized designee ("ADMINISTRATOR").

#### RECITALS

- A. The COMMISSION and CONTRACTOR previously entered into that certain Agreement for the Provision of Project Services dated May 3, 2006, under which the COMMISSION granted funds for the "Project" described in Exhibits A, A-1 and B therein ("Original Agreement").
- B. Pursuant to the Original Agreement, COMMISSION granted to CONTRACTOR funds to further the purposes of and implement COMMISSION's Strategic Plan.
- C. COMMISSION hereby awards an additional \$211,424 to expand Early Literacy in support of the First 5 California School Readiness Program for the period July 1, 2007 through June 30, 2010 to CONTRACTOR and CONTRACTOR desires to accept the additional funding in order to provide additional services under the terms and conditions of the Original Agreement, as amended by this First Amendment. The Original Agreement and this First Amendment are referred to collectively as the "Agreement".
- D. The parties desire by this First Amendment to amend and restate COMMISSION's Maximum Payment Obligation.
- E. The parties desire by this First Amendment to amend and restate Milestone number SSR06-18 from Exhibit A-1, the Work Plan for the period July 1, 2007 through June 30, 2008. This restated Milestone number SSR06-18 from Exhibit A-1 shall replace the existing Milestone number SSR06-18 from Exhibit A-1 in the Original Agreement. The restated Milestone number SSR06-18 from Exhibit A-1 for the period July 1, 2007 through June 30, 2008 is incorporated by reference.
- F. The parties desire by this First Amendment to amend and restate Exhibit B, Project Budget. This restated Exhibit B shall replace the existing Exhibit B in the Original Agreement. A copy of the restated Exhibit B is attached herein and incorporated by reference.

- G. The parties desire by this First Amendment to amend and restate Attachment 1 to Exhibit B, the Staffing Table. This restated Attachment 1 to Exhibit B shall replace the existing Attachment 1 to Exhibit B in the Original Agreement. A copy of the restated Attachment 1 to Exhibit B is attached herein and incorporated by reference.
- H. The parties desire by this First Amendment to amend and restate Attachment 2 to Exhibit B, the Direct Project Expenses Table. This restated Attachment 2 to Exhibit B shall replace the existing Attachment 2 to Exhibit B in the Original Agreement. A copy of the restated Attachment 2 to Exhibit B is attached herein and incorporated by reference.
- I. Capitalized terms in this First Amendment are as set forth in the Original Agreement, or as specifically defined herein.
- J. The parties desire by this First Amendment to set forth certain modifications, and clarifications to the terms and conditions of the Original Agreement.
- NOW, THEREFORE, based upon the foregoing Recitals, which are hereby a substantive part of this First Amendment, and in consideration of the covenants contained herein, COMMISSION and CONTRACTOR hereby agree as follows:
- 1. Maximum Payment Obligation. Additional funding of \$211,424 is provided by COMMISSION to CONTRACTOR by this First Amendment for a cumulative total of One Million, One Hundred Thirty Four Thousand Four Hundred Twenty Four Dollars (\$1,134,424). Paragraph 16 of the Original Agreement, Maximum Payment Obligation, with respect to CONTRACTOR is hereby amended to read as follows: "The 'Maximum Payment Obligation' of COMMISSION to CONTRACTOR under this Agreement shall be ONE MILLION, ONE HUNDRED THIRTY FOUR THOUSAND FOUR HUNDRED TWENTY FOUR DOLLARS or the actual reasonable cost incurred and paid for performance of the services, whichever is less, which amount is the sum of (a) the first allocation of \$923,000 on May 3, 2006, and (b) the second allocation of \$211,424 as specified in the amended and restated Exhibit B to First Amendment to Agreement attached hereto as Exhibit B and fully incorporated herein by this reference."
  - 2. Subparagraph 16.1.1 of the Agreement is hereby amended to read as follows:
- 16.1.1 The Maximum Payment Obligation of COMMISSION to CONTRACTOR for the services to be provided for the period July 1, 2006 through June 30, 2007 shall be \$219,114.18 ADMINISTRATOR and CONTRACTOR may mutually agree in writing to increase the Maximum Payment Obligation for the period specified in this Subparagraph 16.1.1 by an amount(s) not to exceed ten percent (10%).
  - 3. Subparagraph 16.1.2 of the Agreement is hereby amended to read as follows:
- 16.1.2 The Maximum Payment Obligation of COMMISSION to CONTRACTOR for the services to be provided for the period July 1, 2007 through June 30, 2008 shall be \$311,644.82. ADMINISTRATOR and CONTRACTOR may mutually agree in writing to increase the Maximum Payment Obligation for the period specified in this Subparagraph 16.1.2 by an amount(s) not to exceed ten percent (10%)."
  - 4. Subparagraph 16.1.3 of the Agreement is hereby amended to read as follows:

- 16.1.3 The Maximum Payment Obligation of COMMISSION to CONTRACTOR for the services to be provided for the period July 1, 2008 through June 30, 2009 shall be \$301,572. ADMINISTRATOR and CONTRACTOR may mutually agree in writing to increase the Maximum Payment Obligation for the period specified in this Subparagraph 16.1.3 by an amount(s) not to exceed ten percent (10%).
  - 5. Subparagraph 16.1.4 of the Agreement is hereby amended to read as follows:
- 16.1.4 The Maximum Payment Obligation of COMMISSION to CONTRACTOR for the services to be provided for the period July 1, 2009 through June 30, 2010 shall be \$302,093. ADMINISTRATOR and CONTRACTOR may mutually agree in writing to increase the Maximum Payment Obligation for the period specified in this Subparagraph 16.1.4 by an amount(s) not to exceed ten percent (10%).
  - 6. Subparagraph 16.10 is hereby added to the Agreement to read as follows:
- "16.10 The parties agree that additional funding provided under this First Amendment to Agreement shall be used only in payment for approved salaries and indirect costs. CONTRACTOR and ADMINISTRATOR may mutually agree to an annual increase or decrease of the indirect cost rate listed in Exhibit B (Budget) to this Agreement based on a review of the State of California Department of Education independently assigned indirect cost rate(s), provided that COMMISSION's Maximum Payment Obligation in this Agreement does not increase as a result."
- 7. <u>Counterparts</u>. Paragraph 26, "Counterparts", is hereby added to the Agreement to read as follows:
- "26. COUNTERPARTS. This Agreement may be executed in several counterparts, all of which shall constitute but one and the same instrument. Faxed and/or electronically scanned signatures shall have the same force and effect as an original signature."
- 8. Milestone SSR06-18 of Exhibit A-1, the Work Plan for the period July 1, 2007 through June 30, 2008, is hereby amended to read as follows:

<u>Background:</u> Governor Schwarzenegger's proposed \$4.8 billion budget cut to California's schools

would severely damage the quality of education in the State forcing school districts to lay off support staff and teachers from already overcrowded classrooms. These budget reductions would be disastrous to public schools and would mean laying off tens of thousands of teachers, Statewide increases in class size, and the further erosion of the support staff provided to students. This would threaten the progress

that children in California are making.

Rationale: At a time when schools are realizing progress in student learning throughout the

State, this budget reduction represents a giant step backward. Reading scores are up 25%, and math scores have increased 17% in the last four years. This progress cannot continue with these proposed budget cuts to the State's public schools.

WHEREAS, the State budget proposed by Governor Arnold Schwarzenegger is a giant step backward for students that would create chaos in California's public schools with cuts of historic proportion that would derail the progress and threaten the education of millions of California students; and

WHEREAS, on average, school district funds would be cut by \$7.76 million per district; and

WHEREAS, against great odds, California's educators have witnessed how students and schools, despite being constantly asked to do more with less, have been making progress with overall reading scores up 25%, and math scores increasing 17% in the last four years; and

WHEREAS, <u>Education Week</u> now ranks California 46<sup>th</sup> in the nation in per-pupil spending at nearly \$1,900 below the national per-student average, while the State also has some of the largest class sizes in the country and ranks last in the number of counselors, school nurses, and librarians per student; and

WHEREAS, California's educators, school board members, administrators, superintendents, school employees and others are outraged that in the self-proclaimed "year of education", the Governor's proposed budget would slash \$48 billion from the State's public schools over the next eighteen months, including devastating mid-year cuts of \$400 million, and would decimate the State's minimum school funding law, Proposition 98, that voters approved in 1988 and reaffirmed their support for in 2005; and

WHEREAS, slashing the monumental sum of \$4.8 billion from California's schools is the equivalent of laying off more than 107,000 teachers, or 137,000 education support professionals, or cutting perstudent funding by more than \$800, or cutting more than \$24,000 per classroom Statewide, or increasing class sizes Statewide by as much as 35%; and

WHEREAS, students did not create this budget crisis, and their education shouldn't be ransomed to solve the crisis with proposals that don't just mortgage their academic futures, but amount to a foreclosure of hope for generations of families; and

THEREFORE, BE IT RESOLVED, that the Fullerton School District Board of Trustees call on the Governor and the Legislature of the State of California to put students first, reject across-the-board cuts that would damage California's public schools, and protect the voter-approved, minimum school funding law, Proposition 98.

SUBJECT: BUDGET ADVISORY COMMITTEE PRIORITY RECOMMENDATIONS

Background: In November 2007, Dr. Mitch Hovey, Superintendent, convened a Budget

Advisory Committee (BAC) to review the budget process and to establish budget priority recommendations for the 2008/2009 fiscal year and beyond. To

ensure that there was representation from District staff and community members, representatives from CSEA, FESMA, FETA, and the parent/ community participated on this committee. Budget Advisory Committee meetings were held at the Fullerton Public Library on November 28, 2007, December 12, 2007, January 16, 2008 and February 6, 2008 from 3:15 p.m. to 5:15 p.m. CSEA, FESMA, FETA, and the parent/community group were each allowed five (5) votes within their group representation to establish the final

budget priorities for their group. Representatives from District staff and the Budget Advisory Committee will share with the Board of Trustees this evening the Committee's budget priority recommendations for the upcoming 2008/2009

budget.
