However, Public Contract Code Section 20113 allows for award of a contract without competitive bids when there is an emergency to permit the continuance of existing school classes. In times of such emergencies the local school board, with a unanimous vote, finds that an emergency exists and enters into a contract with the approval of the Orange County Superintendent of Schools.

Delay of installation of these relocatable classrooms will negatively impact the educational program at Parks Junior High, Ladera Vista Junior High and Hermosa Drive Schools. Staff is requesting that the Board find that an emergency exists to purchase relocatable classrooms to be placed at Parks Junior High, Ladera Vista Junior High and Hermosa Drive Schools for beginning of school commencing August 2004, and authorize the Assistant Superintendent of Business Services to enter into a contract on behalf of the District for the purchase of relocatable classroom buildings at a cost of \$161,716.80, including tax, delivery and installation.

Staff recommends that the Board of Trustees approve the revision of Change Orders 1-4, removing the scope of unforeseen work directly related to the emergency asbestos removal. As a follow-up to our discussions, the following Tadros & Youssef Construction ('Tadros') Change Order Requests ('COR') were necessitated by the asbestos removal work. Included is a brief description and explanation of each COR.

1. Reinsulate Chiller Pipes (COR PAR-027)

\$11,696.00

The chiller pipes are located in the ceiling space and are insulated to prevent condensation from dripping onto the ceiling tiles. During the asbestos removal work, sections of the insulation were damaged and removed. A Field Directive was issued to Tadros directing them to re-insulate the chiller pipes that had been removed. This \$11,696.00 amount was approved in Change Order No. PAR-002 and included within the total of \$50,995.36.

2. Additional Tackwall Surface (COR PAR-029)

\$88,117.90

During the asbestos removal process, the newly installed tackwall panels were damaged beyond repair. In addition, the surfacing of the moveable wall partitions was damaged. To restore the walls to 'like condition', a Field Directive was issued to Tadros directing them to install new tackwall panels throughout the building. This \$88,117.90 amount was approved in Change Order No. PAR-003 and included within the total of \$84,822.10.

3. Additional Wall Support (COR PAR-028)

\$62,936.46

The existing moveable wall partitions were supported by the ceiling structure. During the asbestos removal, the support system for the ceiling was compromised and had to be re-strengthened. A Field Directive was issued to Tadros to add structural supports to the moveable wall partitions at the ceiling and at the floor connections. This \$62,936.46 amount is being submitted as part of Change Order No. PAR-004 and included within the total of \$194,598.05.

4. Wall Texture (COR PAR-030)

\$1,078.44

During the asbestos removal, a section of the Staff Lounge was 'opened-up' to confirm that no asbestos containing material had fallen into the wall cavity. The existing drywall and plasterboard was removed four feet from the floor. Drywall was reinstalled and a textured coat applied to the wall to provide a more uniformed finish. A Field Directive was issued to Tadros directing them to texture the wall. This \$1,078.44 amount is being submitted as part of Change Order No. PAR-004 and included within the total of \$194,598.05.

5. Repair Damaged Wall (COR PAR-037)

\$1,178.06

A section of the Art Classroom wall was damaged during the asbestos removal process. The wall had to be removed and replaced. In addition, a roof drain within the wall was repaired. A Field Directive was issued to Tadros directing them to remove and replace the wall and repair the roof drain. This \$1,178.06 amount is being submitted as part of Change Order No. PAR-004 and included within the total of \$194,598.05.
