- Background: Since 1979, when Proposition 4 (the GANN Amendment) was approved by the voters of California, all school districts must establish a GANN Limit for the preceding and current fiscal year in accordance with the provision of the GANN Amendment and applicable statutory law.

The California Department of Education is requesting these forms in accordance with Government Code Section 7906 (f), which states:

Each school district shall report to the Superintendent of Public Instruction and to the Director of Finance at least annually its appropriation limit, its appropriations subject to limitation, the amount of its state aid apportionments and subventions included within the proceeds of taxes of the school district and amounts excluded from its appropriations limit, at a time and in a manner prescribed by the Superintendent of Public Instruction and approved by the Director of Finance.

Recalculation of the 2003/04 Appropriations Limitation and Establishing the 2004/05 Estimated Appropriations Limitation Calculations

- WHEREAS, Article XIII B of the California Constitution provides certain limitations and controls on the total annual appropriations of any school district; and
- WHEREAS, Division 9, (commencing with Section 7900) of Title 1 of the Government Code provides for the implementation of Article XIII B; and
- WHEREAS, Government Code Section 7900 provides that the governing body of each school district shall annually adopt a resolution to identify the estimated appropriations limit for the district for the preceding fiscal year.

NOW, THEREFORE, the Board of Trustees of the Fullerton School District hereby resolves and declares as follows:

The actual appropriations limit for 2003/04 was \$58,591,186.76 and the appropriations in the 2002/03 budget did not exceed the limitations imposed by Article XIII B of the California Constitution.

The appropriations limit for 2004/05 is estimated to be \$61,142,312.65 and the appropriations in the 2004/05 budget do not exceed the limitations imposed by Article XIII B of the California Constitution.

BE IT FURTHER RESOLVED, that the documentation used in determining the appropriations limit shall be available to the public at 1401 West Valencia Drive, Fullerton, California 92833.

- Background: Orange County Therapy Services is a certified nonpublic agency that provides services in occupational and physical therapy to children with developmental disabilities and autism.

The District is required by law to conduct an assessment in any area of suspected disability. The assessment must be conducted upon parent request if the student is a resident of the Fullerton School District. The results of the assessment determine a student's eligibility for services. Neither Fullerton School District nor the North Orange County Special Education Local Plan Area (SELPA) has a qualified occupational therapist to conduct assessments and provide therapy services. Orange County Therapy Services has the qualifications and is a state certified nonpublic agency.

- Background:The Children & Families Commission of Orange County proposed a School
Nurse Expansion Project at its December 2003 meeting as an opportunity to
build on current school nursing services funded in conjunction with the School
Readiness Initiative. In February 2004 the Orange County Children and
Families Commission established a School Readiness Nurse Initiative to define
and promote school readiness for all children from prenatal to age five. The
entitlement for this grant comes from Proposition 10 funds to establish a
School Readiness Nurse position in Fullerton School District for two years,
August 2004 through June 2006 utilizing a similar implementation strategy as
the successful funding program for School Readiness Coordinators at school
districts.

The School Readiness Nurse will promote lifelong health and health practices in children 0-5 and their families within the school district boundaries to prevent/decrease health problems, diseases and disorders and/or to facilitate early identification and treatment of health problems; thereby reducing longterm health care costs, promoting quality of life and potential for successful educational experiences.

Claire Y. Morey, OCDE Legal Services, Lee J. Hanson, Risk Services Consultant, ASCIP, and Mark Douglas, Assistant Superintendent of Personnel Services have reviewed this contract agreement, on file in the Superintendent's Office. Recommended changes have been noted on the contract and communicated to the OCDE Superintendent of Schools and the Orange County Children and Families Commission.

Funds from this grant will to be used to support the School Readiness Nurse position for the Fullerton School District.
