This staff development training provides teachers with a system for looking at student work that will result in an increase in consistency in grading, a unified response to struggling writers within and across grade levels and schools, and teacher awareness of student progress. The outcomes for this four-day training are the participants will consistently evaluate student writing using the Fullerton School District 4-Point Writing Rubric to analyze writing content, organization, focus, and language conventions. Teachers will use that information to guide writing instruction in their classrooms.

Last spring, in reviewing benchmark assessments, it became evident that principals and teachers needed further training in Writing Calibration. Educational Services identified a consultant to provide the training. However, after several months of attempting to determine if this consultant would be available, we were told she would not be available after all and were given the name of another consultant to contact. After calendaring the date far in advance, we did not receive confirmation from the replacement consultant until after the last Board meeting; thus, the need for ratification.

A copy of the Independent Contractor Agreement is on file in the Superintendent's office for review.

The intern credential is authorized for two years in the candidate's teaching field; interns cannot teach out of their field. Candidates can become interns when they pass the CBEST, demonstrate subject matter competence, have an offer of an intern teaching position from a participating school district, and are approved for the program. Upon completing all program requirements for advancement to student achievement, interns may use their teaching position as the "student teaching" experience. Mrs. Ballard also thanked the Principals for their excellent leadership.

Superintendent's Report

Dr. McCune reported: the start of the school year has been very smooth; the Back to School events are currently taking place and encourages community members and parents to participate; Trustee Sugarman's son and Dr. Patricia Godfrey's daughter are both getting married this week; sad news of Nicolas student Janette Jimenez who passed away last week, but pleased to share that Kobe Bryant has generously donated \$5,000 to the family; sad news of Golden Hill student Erin Choe who passed away over the holiday weekend.

Information from the Board of Trustees

Trustee Thornley's report: stated she is looking forward to attending the Back to School events; discussed a recent article about the Fullerton Joint Union High School District and their Smaller Learning Community program; the overall theme of the high school district is rigor, relevance, and relationships; stated she would like the District's junior high students to connect with mentors so they are better prepared when they enter high school.

Trustee Bass stated he would like more emphasis on safety messages to parents. Mr. Bass requested that the Maintenance Department review the skateboarding areas at the school sites and to possibly resurface those areas to discourage skateboarding.

Trustee Duncan stated the District is fortunate to have hired many excellent teachers from the large amount of those that applied. Mr. Duncan mentioned that he appreciated what Trustee Thornley said about relationships for students, that it is an extremely powerful motivator for children.

Trustee Sugarman thanked Andy Montoya for the invitation to the New Teachers' Breakfast and commented that the speakers presented interesting financial information to the teachers. Mrs. Sugarman wished a happy year to the four new principals in the District and stated they will be great additions to the schools. Trustee Sugarman commented the All the Arts for All the Kids Pin Auction is October 28, and donations of any kind to be auctioned are welcome.

New FETA President Andy Montoya stated he has been on the Executive Board for five years. Mr. Montoya thanked Randa Schmalfeld and Sue Albano for their efforts regarding the Math grant, and he also stated he has been working with Mark Douglas who has been very helpful.

SUBJECT:	DISTRICT FEE-BASED CHILDCARE
<u>Background</u> :	In Fall 2004 the Fullerton School District initiated fee-based childcare at Fisler, Beechwood, and Acacia Schools. Hermosa, Rolling Hills, and Sunset Lane Schools' fee-based childcare was added in 2005, and Fern Drive was added in Fall 2006. Previously, the YMCA had been in charge of the programs at Hermosa, Rolling Hills and Sunset Lane Schools. The fee-based childcare enrollment at Fisler School is 40 children and 23 in extended kindergarten. Fisler childcare currently has 29 children on the waiting list. In allocating facility space, the State requires 35 square feet per child. At this point in time, Fisler School's room accommodations have been fully utilized for regular education leaving no space for childcare children. The District would like the option of adding an additional portable at Fisler School to accommodate demands.
