SUBJECT: AUTHORIZE SUPERINTENDENT TO INITIATE REFINANCING OF FULLERTON SCHOOL DISTRICT'S 2010 GENERAL OBLIGATION REFUNDING BONDS AND OUTSTANDING CERTIFICATES OF PARTICIPATION

Background: The District was approved to issue \$49.7 million of general obligation bonds with the passage of Measure CC in March 2002. \$40 million of Series A bonds were issued in 2002, and \$9.7 million of Series B bonds were issued in 2005. The District has actively sought to refinance the bonds in order to save the taxpayer the maximum possible amount. In 2010, a portion of Series A bonds were refunded, saving taxpayers \$3 million; and in 2014, Series B bonds were refunded, saving the taxpayer an additional \$0.9 million. As interest rates are currently favorable, the District would like to pursue a refinancing of the 2010 Series A refunding bonds to save the taxpayer an additional \$0.5 million.

> The District issued \$8.9 million of Certificates of Participation in July 2002 for the purposes of making capital improvements to modernize certain school sites in the District and to purchase additional classroom buildings. These Certificates were refinanced in November 2011, saving the District \$0.9 million, and the District would like to pursue an additional refinancing opportunity which would save the District \$127 thousand.

Tim Carty from Piper Jaffrey, the Financial Consultant for the District, will discuss the refinancing variables, as well as the process.

Rationale: The 2010 General Obligation Refunding Bonds and the outstanding Certificates of Participation are currently yielding above-market interest rates, and prudent financial management requires the District to consider refinancing. By approving this item, the Board authorizes the Superintendent to move forward with the refinancing process. Formal authorization documents would then be presented to the Board in November.

# <u>Funding:</u> Costs to refinance the bonds and Certificates of Participation would come out of the refinancing proceeds. No costs would be charged directly to the District.

<u>Recommendation:</u> Authorize Superintendent to initiate refinancing of Fullerton School District's 2010 General Obligation Refunding Bonds and outstanding Certificates of Participation.

- Background: Procure America (PA) provides consulting services to municipalities, government agencies, and school districts for the purpose of reducing and/or recovering costs associated with telecommunications, document management, utility tariff rates, and waste and recycling expenses. The company also assists clients with operational efficiency strategies, supplier invoice auditing, and regulatory compliance.
- Rationale:This agreement (Exhibit 1) will allow PA to analyze District contracts,<br/>past invoices, and other pertinent information related to utilities to identify<br/>potential savings or recovery of costs. After the initial analysis, the<br/>company will continue working with the District on improving operational<br/>efficiency, compliance issues, anticipating changes in service needs, and<br/>ensuring accountability by service providers. If the District elects to<br/>proceed with any of the recommendations made by PA, the company will<br/>receive a 50% revenue share based on the amount saved or recouped<br/>over a 36-month period. The company will work with the District over the<br/>contract term to ensure best practices are in place across the board and<br/>to identify further efficiencies and vendor accountability. There is no cost<br/>to the District for the review if the company's recommendations are not<br/>implemented and/or if no net savings are realized by the District.
- <u>Funding:</u> Net positive impact as any fees paid to the company will be generated by the net savings delivered through the review recommendations and implementation. Any potential fees to the company are paid in arrears after the District realizes the savings.
- <u>Recommendation:</u> Approve agreement with Procure America to provide cost reduction consulting services for a period of 36 months beginning with receipt of the first invoice per expense category from Procure America.

# Statement of Work

**1.) STATEMENT OF WORK:** Procure America (PA) is pleased to provide the following cost reduction consulting services to Client (as selected by Client) with the resolve and purpose of reducing or recovering costs.

- Waste & Recycle
- **Telecommunications**
- Financial Services
- Utilities
- Document Management
- Treasury Services

PA shall use its best efforts to obtain cost savings for Client's benefit by analyzing Client's policies, procedures, supplier contracts, past invoices and other pertinent information as it relates to the above selected expense categories set for review. PA will further gather information as to Client's needs (past, present and future) from Client's service providers so as to build a solution that not only lowers cost, but also matches Client's operational and corporate requirements and expectations. After analyzing Client's current spending patterns, PA shall provide Client with a full report outlining PA's observations. PA's report will include a review of operations, cost reduction recommendations and potential service level enhancements.

**2.) POST REVIEW PHASE:** For the entire balance of the relationship with Client, PA will continue to consult with Client in an effort to continuously look for efficiencies in the chosen areas of focus. Periodically the PA team will review Client's invoicing and deliverables to ensure accountability by Client's service providers with respect to the spirit and intent of the agreement between Client and the third party service provider. This review will take into account service levels, cost controls and overall client satisfaction. Further, PA will continuously consult with Client to anticipate changes in service needs to ensure that the proper service provider, contract and procedures are in place to address Client's go forward requirements.

**3.) REVENUE SHARE:** Client has in place certain existing costs as it pertains to the requested expense categories selected for review ("Established Rates"). PA's report will document the Established Rates for each service or product chosen for review and outline the methodology for PA's findings. Client and PA will then discuss, agree and document the Established Rates for the targeted service or product. After the initial review is completed, PA will produce an addendum to this agreement that outlines the Established Rates, billing cycles and other operational details associated to the go forward strategy. If Client elects to proceed with any or all of the recommendations as set forth in PA's report, Client agrees to compensate PA for the savings associated with the proposal. The Revenue Share to PA is fifty percent or half of the actual realized savings measured by the difference between the agreed upon Established Rates and Client's new costs as set forth in PA's report and documented through actual realized savings.

In some cases, the PA staff may discover over billing, credits, rebates or other sources of revenue. This income is to be considered expense reduction for purposes of this Agreement and will be accounted for in the same manner as the expense reduction savings. This revenue shall be shared with PA after the refunds or other credits are realized by Client. In other cases, PA may have the ability to recover rebates or other compensation by contractors or service providers. PA shall disclose this compensation to Client and both parties shall share this revenue as savings at the time the revenue is received. **4.) However, if Client does pursue any or all of the documented review recommendations (with or without PA's further assistance), PA is entitled to the appropriate revenue share as outlined in Section 3 above. Client agrees to grant PA the right to review any materials (books, records, invoices, contracts or other information) related to the provider accounts directly from the providers personnel and provider websites. Any additional Client request or engagements, written or otherwise to review supplementary expenses or income streams will also be governed by this agreement.

In the event of any dispute under or relating to the terms of this Agreement, or breach thereof, it is agreed that the same will be submitted to arbitration to the American Arbitration Association, in Orange County, California. This agreement is entered into between the Fullerton School District (FSD) and the Fullerton Elementary Teachers Association (FETA).

FSD and FETA have determined that it is in the best interest of all parties to establish a new certificated position, "Focus Teacher," for the purposes of providing instruction and intervention to students related to a school's specific focus and available site funds. A school's focus shall be determined by the school's Leadership Team and the site administrator with staff input.

FSD may employ certificate temporary employees with an appropriate credential as Focus Teachers pursuant to Education Code section 44909.

Between July 1, 2017 and June 30, 2018 such employment shall be up to one school year for a cumulative total not to exceed one hundred thirty (130) workdays and a total of or more than nineteen (19) hours per week and a cumulative total not to exceed five hundred seven (507) hours per school year. Such employees would be entitled to a 10-minute break during their work shift and the option of establishment of an unpaid thirty (30) minute duty-free lunch period by mutual agreement between the Focus Teacher and the principal.

Service as a Focus Teacher shall not be included in computing the service required to become a permanent certificated employee of FSD. A Focus Teacher will be credited for one (1) year of teaching experience for every two (2) years of consecutive service as a Focus Teacher with the District if the employee has worked one hundred thirty (130) days and at least three and three-quarters (3.75) hours per day in each previous school year and is subsequently employed by FSD in a contracted position paid on the Certificated Salary Schedule.

A Focus Teacher may apply for open positions in FSD during his/her temporary contract period and will be release from the Focus Teacher contract if offered such position.

Focus Teachers shall be compensated at the hourly rate of Step 1 Column 1 on the Certificated Salary Schedule (\$37.45 for the 2017-2018 school year).

Focus Teachers will be evaluated under the provisions of the Evaluation Memorandum of Understanding between FSD and FETA dated August 9, 2017.

The Focus Teacher shall be covered by the terms and provisions of the contract between FSD and FETA except as follows:

- Article 8 Hours of Employment
- Article 9 Work Year
- Article 10 Transfers
- Article 12 Peer Assistance and Review
- Article 16 Salaries
- Article 17 Fringe Benefits
- Article 23 Early Retirement

Beginning with the 2017-2018 school year, the Fullerton School District (FSD) will be offering students the option of taking Physical Education classes through an independent study program for students in seventh ( $7^{\text{th}}$ ) and eighth ( $8^{\text{th}}$ ) grades as described in Board Policy 6142.7.

The students taking Physical Education classes through an independent study program need to have single subject physical education teacher as the supervisor. These procedures shall be followed for single subject physical education teachers supervising students in independent study physical education classes:

- An email will be sent to all certificated employees who have informed FSD that they hold a single subject physical education credential requesting that they respond regarding their interest in supervising students who choose to take Physical Education classes through an independent study program.
  - Certificated employees who do not respond by the date listed in the email will not be considered for this assignment(s).
  - Teachers will be selected using a rotating order seniority list from most senior to least senior. Teachers who do not respond by the due date or who refuse an assignment when it is offered will be treated as if they had taken an assignment and moved to the bottom of the rotating seniority list.
- The certificated employee who accepts this assignment will be responsible for monitoring and verifying the ISPE activity logs for a maximum of ten (10) students who are taking Physical Education classes through an independent study program.
  - ISPE logs need to be reviewed, verified, and signed-off every trimester/semester.
  - ISPE logs will be sent to the Director of Administrative Service, Helene Morris, no later than one (1) week after the end of the trimester/semester.
  - Review of the ISPE logs should take maximum of fifteen (15) minutes per trimester/semester per student.
- The certificate employee who accepts and completes the requirements of this assignment shall receive an annual stipend of \$300.

### Memorandum of Understanding (MOU)

September 6, 2017

Pursuant to negotiations between the Fullerton School District (District) and the California School Employees Association (CSEA) and its Fullerton Elementary Chapter 130, this memorandum of understanding has been reached to clarify the language related to Article 13 – Transportation, of the Collective Bargaining Agreement between the parties. This MOU will take effect for the 2017-2018 school year and will remain in effect until the parties are able to negotiate and ratify changes to the Collective Bargaining Agreement between the Fullerton School District and CSEA and its Fullerton Elementary Chapter 130. This MOU is non-precedent setting.

• Article 13.2 shall be modified as follows:

**DEFINTION OF A FIXED ROUTE:** A fixed route shall include (1) twentyfive (25) minutes of walk to the bus plus equipment-check out of buses with hydraulic brakes, or thirty-five (35) minutes to walk to the bus plus equipment check-out of buses with air-brakes, (2) 30 minutes for clocking out plus clean up and lock up of equipment, (3) forty-five (45) minutes per week to wash-big busses; thirty (30) minutes per week to wash-little-busses plus, (1) five (5) minutes clock/in out time per occurrence for each of the following: return to the lot after morning runs, going to the bus prior to midday runs, return to the lot after midday runs and going to the bus prior to afternoon runs. A fixed route shall include one or more of the following: morning run, afternoon run, midday run, and/or therapy run. A fixed route shall include:

- 1. Five (5) minutes of clock in/out and walk time at the beginning and end of each run.
- 2. Twenty (20) minutes of equipment check out for buses with hydraulic brakes, OR thirty (30) minutes of equipment check out for buses with air brakes (for each required equipment check out).
- 3. Fifteen (15) minutes of clean up and lock up time of equipment per each run.

- 4. Forty-five (45) minutes per week to wash Type I buses with air brakes and thirty (30) minutes per week to wash Type II with hydraulic brakes.
- 5. Actual time it takes to fuel a bus.
- Article 13.10 shall be modified as follows:

**FIELD TRIP ASSIGNMENTS:** Field trip assignments shall be distributed and rotated as equally as reasonably possible among bus drivers in the bargaining unit. If a field trip becomes available due to the unavailability of the previously assigned driver, such trip will be offered to the driver who is the highest on the field trip rotation list at no loss to their place in rotation and so on until the trip is taken. A driver shall-have fifteen (15) minutes-for clean up and lock up of field trip busses other than the driver's regularly assigned-bus. A field trip assignment shall include:

- 1. Five (5) minutes of clock in/out and walk time at the beginning and end of each run.
- 2. Twenty (20) minutes of equipment check out for buses with hydraulic brakes, OR thirty (30) minutes of equipment check-out for buses with air brakes (for the driver's first run of the field trip assignment).
- 3. Twenty (20) minutes of clean up and lock up time of equipment per run.
  - a. Drop and return field trips shall provide the twenty (20) minute clean up and lock up time for each run. This time may be extended as necessary with the pre-approval of the supervisor.
  - b. Drivers with field trip assignments that require the driver to stay and remain with paid stand-by time will only be paid for one (1) twenty (20) minute period for clean up and lock up at the end of the field trip assignment. This time may be extended as necessary with the pre-approval of the supervisor.
- 4. Actual time it takes to fuel a bus.
- Article 13.11 shall be modified as follows:

<u>SPECIAL TRIP ASSIGNMENTS</u>: Weekend, evening, holiday, and sport trips will be assigned to drivers who sign up for them on a rotation basis. If no regular driver has signed up, the trip will be available to a probationary driver. If no probationary regular driver has signed up, the trip will be available to a substitute driver. If no substitute driver is available, the run shall be offered again to the most senior driver on the rotation list. That run shall not be charged against the placement in rotation of the driver who accepts the run during the secondary sign up. A driver will-have fifteen (15) minutes for clean up and lock up of special trip buses other than the driver's regularly-assigned bus. A special trip assignment shall include:

- 1. Five (5) minutes of clock in/out and walk time at the beginning and end of each run.
- 2. Twenty (20) minutes of equipment check out for buses with hydraulic brakes, OR thirty (30) minutes of equipment check out for buses with air brakes (for the driver's first run of the special trip assignment).
- 3. Twenty (20) minutes of clean up and lock up time of equipment per run.
  - a. Drop and return field trips shall provide the twenty (20) minute clean up and lock up time for each run. This time may be extended as necessary with the pre-approval of the supervisor.
  - b. Drivers with special trip assignments that require the driver to stay and remain with paid stand-by time will only be paid for one (1) twenty (20) minute period for clean up and lock up at the end of the special trip assignment. This time may be extended as necessary with the pre-approval of the supervisor.
- 4. Actual time it takes to fuel a bus.

This MOU is subject to ratification by the CSEA and its Fullerton Elementary Chapter 130 membership, CSEA Policy 610 requirements and approval by the Fullerton School District Board of Trustees.

# EDUCATIONAL CONSULTING AGREEMENT College Orientation Program

This educational consulting agreement (the "Agreement") is made and entered into between **Fullerton School District**, hereinafter referred to as (the "FSD") and **North Orange County Community College District** serving in the role of professional services provider, hereinafter referred to as (the "NOCCCD") as of the date that this Agreement is executed by all parties (the "Effective Date").

# RECITALS

The NOCCCD's Fullerton College provides advisory education through its Computer Information System - Gaming course, Introduction to Computer Game Design (the "Course"); and

FSD is in need of such Course for its junior high school students who are also able to earn 3 units during the session in which they enrolled; and

The Course is offered on a limited basis during the 2018 spring semester *by* the NOCCCD's Fullerton College at Parks Junior High School; and

The NOCCCD is specially trained, experienced, and competent to provide the Course; and

The parties now find it to be mutually beneficial for the Course to be made available to FSD students.

The purpose of this Agreement is to set forth the terms and conditions pursuant to which the parties will institute the Course at the NOCCCD.

# THE PARTIES AGREE AS FOLLOWS:

# I. GENERAL INFORMATION ABOUT THE PROGRAM

- A. The commencement date for the provision of services under this agreement shall be January 28, 2018 but no sooner than the Effective Date, with all services performed and completed no later than May 31, 2018;
- B. Students participating in classes will enroll through the NOCCCD's Fullerton College in accordance with established college registration procedures for Concurrent Special Admit Students;
- C. The length of course is a total of 54 hours;
- D. Both the NOCCCD and FSD agree that a total number of 30 students are expected to participate in the program;

E. Classes offered pursuant to this Agreement will be conducted on such days and times and at such locations as mutually agreed upon by the NOCCCD and FSD, provided that no instruction shall occur on any day established holidays for either the NOCCCD or FSD.

# II. RESPONSIBILITIES OF THE NOCCCD

- A. <u>Academic Responsibility</u>. The NOCCCD shall provide credit instruction for a total of one (1) college course of Computer Information System Gaming course, Introduction to Computer Game Design, during the 2018 spring semester. Classes offered shall be accessible to junior high school students from the sites at which the classes are offered as well as to students from other sites as determined by NOCCCD.
  - i. NOCCCD will provide instruction for the specified classes in compliance with the NOCCCD's designated curriculum and class schedule and in compliance with instructional policies and procedures.
  - ii. NOCCCD shall document all student enrollment and attendance.
  - iii. NOCCCD shall create an effective teaching-learning environment and maintain effective communication with FSD and junior high school campus staff.
- B. <u>NOCCCD Classification</u>. NOCCCD's employees shall in no way be deemed employees of FSD. NOCCCD shall be under the control of FSD as to the result to be accomplished and not as to the means or manner by which such result is to be accomplished.
- C. <u>NOCCCD Supervision</u>. All instruction provided by the NOCCCD shall be under the supervision and control of appropriately credentialed employees.
- D. <u>**Compliance**</u>. NOCCCD shall comply with applicable federal, state and local laws, rules, regulations, and ordinances including workers' compensation requirements.
- E. **<u>Registration Fee</u>**. NOCCCD shall not collect a registration fee from any student enrolled pursuant to this agreement nor claim state apportionment FTEs for any student so enrolled.

# III. RESPONSIBILITIES OF FSD

- A. <u>Student Outreach</u>. FSD shall be responsible for providing services with respect to student outreach and recruitment of students for the program.
- B. <u>**Technical Support**</u>. FSD shall provide and maintain facilities, equipment, textbooks and instructional supplies and materials that are necessary for the provision of instruction by the NOCCCD pursuant to this Agreement, without charge to the NOCCCD, or without charge to any student receiving instruction pursuant hereto.

C. <u>NOCCCD Fee and Timing of Such Payment</u>. FSD shall pay NOCCCD an amount not to exceed Four thousand six hundred dollars (\$4,600). The maximum payment shall include all related administrative and instruction costs. Payment to NOCCCD shall be made no later than thirty (30) days after submission of invoice to FSD.

# IV. INSURANCE

- A. <u>Insurance</u>. Both the NOCCCD and FSD each agree to secure and maintain at all times throughout the term of this Agreement, each at its sole cost and expense, comprehensive general liability insurance in amounts reasonably necessary to protect itself against liability arising from any and all negligent acts, or omissions of its employees, officers or volunteers in the performance of this Agreement. Coverage under such professional and commercial general liability insurance shall not be less than one million dollars (\$1,000,000) per occurrence, and three million dollars (\$3,000,000) in aggregate.
- B. It is expected that both the NOCCCD and FSD will provide the necessary worker's compensation for its own employees and students, if appropriate.

# V. INDEMNIFICATION

The NOCCCD agrees to defend all claims of loss, indemnify and hold harmless FSD and its officers, agents and employees from any and all liability for personal injury, damages, wrongful death or other losses and costs, including but not limited to reasonable attorney fees and defense costs, arising out of the negligent acts or omissions, willful misconduct of the NOCCCD or its employees, officers, or volunteers in the performance of this Agreement.

The FSD agrees to defend all claims of loss, indemnify and hold harmless NOCCCD and its officers, agents and employees from any and all liability for personal injury, damages, wrongful death or other losses and costs, including but not limited to reasonable attorney fees and defense costs, arising out of the negligent acts or omissions, willful misconduct of the FSD or its employees, officers, or volunteers in the performance of this Agreement.

# VI. ASSIGNMENT

This Agreement is not assignable without written consent of the parties hereto.

# VII. TERM AND TERMINATION

<u>**Term**</u>. This Agreement shall remain in full force and effect beginning on the Effective Date of this Agreement through May 31, 2018.

<u>**Termination**</u>. This Agreement may be terminated at any time by written Agreement or upon 30 days' advance written notice by one party or the other, PROVIDED, HOWEVER, that in no event shall termination take effect with respect to currently enrolled FSD students who shall be permitted to complete their course for any semester in which termination would otherwise occur.

#### Marsa Miller Consulting, Inc. School Transportation Consultation Services Marsa L. Miller Agreement for Transportation Management Assistance

This Agreement is entered into between Marsa L. Miller, owner Marsa Miller Consulting, Inc, acting as an independent consultant (CONTRACTOR) AND Fullerton School District (DISTRICT). AND IS DATED, FOR REFERENCE, October 05, 2017. The parties agree as follows:

1. **CONTRACTOR** agrees to perform during the term of this Agreement, the tasks, obligations and services set forth in the "Scope of Services" attached to and incorporated into this Agreement as Appendix A.

**DISTRICT** agrees to pay **CONTRACTOR** a daily rate of **\$850.00** per day for each day (8 hours per day) of on-site Transportation Management Assistance, which includes all expenses and not to exceed **41 workdays** / **\$34,850.00**. All payments will be based upon invoices submitted to the **DISTRICT** by **CONTRACTOR**.

**CONTRACTOR** will invoice the **DISTRICT** for services performed on the first day of each month following through the Transportation Management Assistance Agreement. The **DISTRICT** will render payment to **CONTRACTOR** within 30 days of receipt of invoices.

- 2. **TERM OF AGREEMENT**, the term of this Agreement begins on October 18, 2017 and ends December 21, 2017. Extension or Renewal requires approval of the **DISTRICT**. The daily rate will not be increased upon extension of the Agreement without approval of the **DISTRICT**. This Agreement may be terminated by the **DISTRICT** at any time with 10 days prior written notice to **CONTRACTOR**. In the event of termination for reasons other than cause, the **DISTRICT** will pay **CONTRACTOR** for work done up to the time of termination. In the event of termination for cause, **CONTRACTOR** need be compensated only to the extent required by law.
- 3. **PERFORMANCE PLAN**, work defined in Appendix A is to be completed daily by assignment request of the DISTRICT. All services required of the **CONTRACTOR** will be completed on or before the specified end of the Agreement.
- 4. MAINTENANCE OF RECORDS AND ASSIGNMENT OF COPYRIGHTS, CONTRACTOR will maintain full and accurate records regarding this Agreement and will make them available to the **DISTRICT** for inspection at any time. **CONTRACTOR's** work product generated under this Agreement shall be the property of the **CONTRACTOR**.

- 5. STATUS OF CONTRACTOR, agree that CONTRACTOR, in performing the services specified by this Agreement, shall act as an independent CONTRACTOR and shall have control of all work and the manner of which it is performed. CONTRACTOR shall be free to contract for similar service to be performed for other vendors while under contract with the DISTRICT; CONTRACTOR will not accept such engagement which interferes with performance under this Agreement. CONTRACTOR is not entitled to participate in any pension plan, insurance, bonus or similar benefits the DISTRICT provides for its employees.
- 6. CONFLICT OF INTEREST: CONTRACTOR represents that it has no existing financial interest and will not acquire any such interest, direct or indirect, which could conflict in any manner or degree with the performance or services required under this Agreement and that no person having any such interest shall be subcontracted in connection with this Agreement, or employed by the CONTRACTOR. CONTRACTOR will take all necessary steps to avoid the appearance of a conflict of interest and shall have duty to disclose to the DISTRICT prior to entering this Agreement any and all circumstances existing at such time which would pose a potential conflict of interest.
- 7. **CONFIDENTIALITY:** All communications and information obtained by the **CONTRACTOR** from the **DISTRICT** relating to this Agreement and all information developed by **CONTRACTOR** under this Agreement are confidential. Should there be a need for the **CONTRACTOR** to maintain on its servers and/or other data storage media, personnel and/or student information protected by the Family Educational Rights and Privacy Act Regulations 34 CFR Part 99 (FERPA) or the Health Insurance Portability and Accountability Act (HIPAA), Consultant must take appropriate measures to ensure the security of said information and maintain its confidentiality according to applicable regulations.
- 8. HOLD HARMLESS, CONTRACTOR shall hold harmless the DISTRICT; its officers, agents and employees from all suits, claims, and liabilities resulting from negligent acts or omissions of CONTRACTOR, taken under this Agreement, which may be incurred by reason of:

(a) Liability for damages for: (1) death or bodily injury to person; (2) injury to loss or theft of property; or (3) any other loss, damage or expense arising out of (1) or (2) above, sustained by the **CONTRACTOR** or any person, firm or corporation employed by the **CONTRACTOR**, either directly or by independent contract, upon or in connection with the Services called for in this Agreement, however caused, except for liability for damages referred to above which result from the sole negligence or willful misconduct of the **DISTRICT** or its officers, employees or agents.

(b) Any liability for damages which may arise from the furnishing or use of any copyrighted or uncopyrighted matter or patented or unpatented invention under this Agreement.

9. INSURANCE: CONTRACTOR shall, at CONTRACTOR's sole cost and expense, maintain in full force and effect the following insurance coverage from a California licensed insurer with an approved self insurance program, sufficient to cover any claims, damages, liabilities, costs, and expenses (including attorney fees) arising out of or in connection with CONTRACTOR's fulfillment of the obligations under this Agreement.
