follows:

Pathfinder Ranch Outdoor Education School: This will be Valencia Park's 12th year returning to Pathfinder Ranch. The curriculum provides diverse and scientific emphasis in the areas of ecology, survival skills, horses and rock climbing. Prior to attending, students will practice normal academic grade level skills in reading, writing and math with special emphasis on geology, landform interpretation, physical geography and moderate hiking. One hundred-thirty students will participate in the three-day program. Participating teachers and principal are Robert Rivera, Kirsten Hubbard, Thuy Cat-Aurelio, Elena Perez-Wallace, and Marilyn White. Seven volunteer parents will also attend. The cost is \$125.00 per student.

Orange County Department of Education

<u>Alpine Meadows:</u> This field trip is an extension of the sixth grade class curriculum of science learning. The county provides two resource books of pre and post activities including curriculum, vocabulary and social skill improvement activities.

One hundred fifteen students from Laguna Road School will participate in the four-day programs. Participating teachers are Enoch Yousling, Bethanie Collins, Kelly Pellizzari, and Deborah McKechnie. The cost is \$350.00 per student.

Copies of the field trip requests are on file in the Superintendent's office.

Funding: There is no cost to the District and transportation costs are included in the

fundraising efforts. Fundraising activities will be conducted by the PTA and include Santa's Workshop and school sales of water bottles, snacks, carnival, bake sale, etc., throughout the year. Students will follow District Board Policy regarding fundraising. Scholarship funds will be established for those who may

have difficulty raising the funds.

The first AMAO 1 specifies annual increases in the percentage of students making progress in learning English. The percent of students required to meet

AMAO 1 in 2003-2004 was 51 percent. English learners (64.4%) in the

Fullerton School District met and exceeded this target.

The second AMAO 2 specifies annual increases in the percentage of students attaining English proficiency. The percent of students required to meet AMAO 2 in 2003-2004 was 30 percent. English learners (45.7%) in the Fullerton School

District met and exceeded this target.
