REGULAR MEETINGS OF THE BOARD OF TRUSTEES are held in the District Administration Building Board Room, unless otherwise noted, at 5:00 p.m. with closed session, 6:00 p.m. open session. Board meetings are scheduled once during the months of January, March, April, July, August, November, and December and twice during the months of February, May, June, September, and October. The Regular Board agenda is posted a minimum of 72 hours prior to the meeting, and a Special Board meeting agenda is posted a minimum of 24 hours prior to the meeting.

AGENDA ITEMS - Per Board Bylaw 9322, a member of the public may request that a matter within the jurisdiction of the Board be placed on the agenda of a regular meeting. The request must be in writing and submitted to the Superintendent's Office with supporting documents and information. The Board President and Superintendent shall decide whether a request is within the subject matter jurisdiction of the Board. Items not within the subject matter jurisdiction of the Board may not be placed on the agenda. In addition, the Board President and/or Superintendent shall determine if the item is merely a request for information or whether the issue is covered by an existing policy or administrative regulation before placing the item on the agenda.

PUBLIC COMMENTS/PERSONS ADDRESSING THE BOARD – The Board meeting follows rules of decorum. Per Board Bylaw 9323, the Board shall give members of the public an opportunity to address the Board on any item of interest to the public that is within the subject matter jurisdiction of the Board, either before or during the Board's consideration of the item. At a time so designated on the agenda at a regular meeting, members of the public may bring before the Board-matters that are not listed on the agenda that are within the jurisdiction of the Board. The Board shall take no action or have discussion on any item not appearing on the posted agenda, except as authorized by law. Furthermore, the Board may respond to the public by referring the comment/question to the Superintendent for a response or by asking the Superintendent to report back to the Board concerning the matter.

Persons wishing to address the Board are requested to complete and submit a "Request to Speak" slip to the secretary. A person wishing to be heard by the Board shall first be recognized by the President and shall then proceed to comment, beginning with stating his/her name for the record. Individual speakers shall be allowed three minutes to address the Board on each agenda or nonagenda item. The Board limits the total time for public input on each item to 20 minutes. The total time allowed for public comment shall be 30 minutes. Public comments about an item that is on the posted agenda will be heard at the time the agenda item is considered by the Board. Public comments about an item that is not on the posted agenda will be heard at the beginning of the Board meeting agenda. With Board consent, the President may increase or decrease the time allowed for public presentation, depending on the topic and the number of persons wishing to be heard. The President may take a poll of speakers for or against a particular issue and may ask that additional persons speak only if they have something new to add.

CONSENT ITEMS - These items are considered routine and will be acted upon by one motion unless a member of the Board or staff requests that an item be discussed and/or removed from the consent calendar for separate action.

Jamba Juice fruit smoothies are

served at all Fullerton School District school/junior high school sites.

purchase them on a regular basis. These fruit smoothies combine real, whole fruit, and 100% fruit juices. By offering these wholesome fruit smoothies, Nutrition Services promotes the concept of healthy foods as set forth in the "Healthy Food Guidelines Resource Guide" published by the District on June 19, 2008, and complies with Board Policy Number 5030 (Student Wellness) adopted on November 28, 2006. Smoothies are sold as an à la carte item to 6<sup>th</sup>, 7<sup>th</sup>, and 8<sup>th</sup> grade students at the middle school/junior high school and K-8

school sites.

### SCHOOL SUPPLY AGREEMENT

**This SCHOOL SUPPLY AGREEMENT** (this "Agreement") is made and entered into as of Monday, July 1, 2013 by and between the undersigned (hereinafter referred to as "Company") and Jamba Juice Company, a California corporation (hereinafter referred to as "Jamba").

### **RECITALS**

WHEREAS, Company serves food and beverage products during the school day to students attending the schools listed on Exhibit A, attached hereto and incorporated herein by this reference (the "Schools"); and

WHEREAS, Jamba wishes to provide the products listed on Exhibit B, attached hereto and incorporated herein by this reference (the "Products"), to Company to be sold and served by Company during the school day to students attending the Schools, all subject to the terms and conditions set forth herein.

### **AGREEMENT**

**NOW THEREFORE,** in consideration of the premises and the terms, covenants and conditions contained herein, the parties hereto hereby agree as follows:

# **Article 1: Sale and Purchase of Products**

- 1.1 Jamba shall sell and deliver the Products to the Schools, and Company shall purchase the Products from Jamba, all in accordance with the terms and conditions set forth herein. Title, possession and risk of loss shall pass to Company upon delivery. Product deliveries shall occur <u>One</u> time per week at each of the Schools, with increasing or decreasing frequency as shall be agreed between the parties. A standing order shall be established at each of the Schools and Company must call at least 24 hours in advance with any order adjustment. In all cases, a minimum of <u>45</u> Products per School delivery is required. Products are to be delivered to each School between 8am and 2pm, subject to adjustment as shall be agreed between the parties.
- 1.2 Company shall sell and serve the Products to students at the Schools only during the school day of delivery of the Products to Company and shall dispose of all remaining Products, if any, at the end of each

school day. Products are not returnable (except to the extent of rejected Product), and Company shall be solely responsible for any waste associated with such disposal.

### **Article 2: Term**

This Agreement shall commence on August 1st, 2013 and remain in full force and effect until June 30<sup>th</sup>, 2014, subject to early termination as provided herein.

# **Article 3: Warranty**

- Jamba warrants to Company that, at the time of delivery by Jamba, all Products shall (1) conform to the formulations, specifications, and standards of the same Products being sold at Jamba's retail stores, subject only to a smaller portion size, if applicable; (2) meet the minimum nutritional requirements of the federal National School Lunch Program applicable to the Schools; (3) meet the minimum nutritional requirements of the State where the Schools are located, applicable to the Schools; (3) be manufactured under sanitary conditions in full compliance with all applicable laws, including but not limited to, those promulgated by FDA, USDA, OSHA, and FTC, and in accordance with industry standards; (4) be free from any manufacturing defect; (5) be merchantable food products fit for human consumption; (6) not be adulterated within the meaning of the Food, Drug & Cosmetic Act, as amended ("FD&C Act"); (7) not be an article which may not under the provisions of Sections 404 and 405 of the FD&C Act be introduced into interstate commerce; and (8) not be adulterated within the meaning of the pure food laws or ordinances of the State or City in which Products are sold.
- 3.2 Company shall maintain all of the facilities, furniture, fixtures and equipment used to serve food and beverages at the Schools in good operating condition at all times. Facilities, furniture, fixtures and equipment located at the Schools shall be subjected to periodic sterilization and such other procedures by Company as may be required under all federal, State and local laws, ordinances, regulations and governmental orders. Once delivered, Company shall store, prepare, handle, and serve all Products strictly in conformance to all federal, State and local laws, ordinances, regulations and governmental orders, including all health and safety laws and regulations. Company shall abide by all instructions and procedures established by Jamba with respect to the storing, maintaining and serving of the Products. Company shall serve the Products only in the serving containers provided by Jamba.

# **Article 4: Pricing and Payment**

- 4.1 The costs of the delivered Products to Company shall be as set forth on Exhibit B. With each delivery of Products, Jamba shall provide a delivery slip showing the exact quantity of each Product delivered. The delivery slip must be signed by an authorized Company representative. Jamba shall submit an invoice on a monthly basis showing the Products purchased by Company, which invoice shall include the delivery slips to support the amount billed. Company shall pay the amount due to Jamba within thirty days of its receipt of such invoice.
- 4.2 Non-conforming Products may be rejected by Company, and Company shall be entitled to a full credit therefor.
- 4.3 Company acknowledges and understands that all prices of the Products are exclusive of any applicable sales and other taxes or fees from the sale of Product to students at the Schools. In support of such pricing, Company shall provide Jamba with a valid and applicable sale for resale exemption certificate, sales tax exemption certificate or other applicable exemption certificate.
- 4.4 If Company or its designee is a non-profit organization, it may be eligible for Jamba's fundraising and give-back program. Company or its designee must complete Jamba's fundraiser information form and provide a

completed W9 form. If Company or its designee is eligible, Jamba will donate 20% of the proceeds collected under this Agreement to the non-profit organization.

### **Article 5: Indemnification**

- Jamba shall indemnify and hold harmless Company, and its officers, directors and employees, from any liability, loss, cost, damage, suit, penalty, claim and demand of every kind and nature (including, without limitation, reasonable attorneys' fees and disbursements) arising out of, by reason of, or resulting from (i) Jamba's breach of any of the terms or conditions of this Agreement, or (ii) any conditions created by, or any act, omission or negligence on the part of Jamba. This paragraph shall survive the termination or expiration of this Agreement.
- 5.2 Company shall indemnify and hold harmless Jamba and its officers, directors and employees, from any liability, loss, cost, damage, suit, penalty, claim and demand of every kind and nature (including, without limitation, reasonable attorneys' fees and disbursements) arising out of, by reason of, or resulting from (i) Company's breach or failure to perform any of the terms or conditions of this Agreement, or (ii) any conditions created by, or any act, omission or negligence on the part of Company. This paragraph shall survive the termination or expiration of this Agreement.
- 5.3 In no event shall either party be liable for any consequential damages or loss of profits which it shall suffer arising out of (a) and (b) above.

# **Article 6: Insurance.**

At the time of the execution of this Agreement, Jamba shall, within ten (10) days thereof, furnish and deposit with Company one original copy of all required insurance certificates designated in this Section. All insurance policies shall be issued by an insurance company authorized by law to conduct business in the State where the Schools are located. Such insurance companies and policies are subject to the prior reasonable approval and acceptance of Company.

Jamba shall, at its sole cost and expense, procure and maintain the following types and limits of insurance, additional insured endorsements and cancellation clauses throughout the term of this Agreement:

- (1) <u>Workers' Compensation</u>. In accordance with statutory limits. Employers Liability with limits not less than \$500,000 per occurrence.
- (2) <u>Comprehensive General Liability</u>. Written on an occurrence basis, no less than \$2,000,000 per occurrence and \$2,000,000 general aggregate for bodily injury and property damage liability, including broad form property damage, personal injury (covering claims arising out of false arrest, false imprisonment, defamation, libel and slander, discrimination and invasion of privacy), independent contractors and contractual liability covering liability assumed under the indemnification provisions contained in this Agreement.
- (3) <u>Comprehensive Automobile Liability</u>. Covering owned, non-owned and hired vehicles providing bodily injury and property damage all on a per occurrence basis, at a combined single limit of \$1,000,000.

All policies shall be written with insurance companies with ratings of not less than A- and in a Financial Size Category of not less that XII, as rated in the most current available "Best's" insurance reports.

Each policy shall name the Company as an additional insured. Each policy shall provide for thirty (30) days' prior written notice to the Company of any cancellation or change in such policy if any such change would

cause the insurance coverages provided to be less than those required by this section. Certificates of insurance shall be provided upon request during the term hereof.

### **Article 7: Default and Termination**

- 7.1 Either Party shall have the right to terminate this Agreement upon a material default hereunder by the other party, which default has not been cured by within ten (10) days after notice thereof by the non-defaulting party to the defaulting party.
- 7.2 Either party may terminate this Agreement at any time at its sole discretion, without cause, on thirty (30) days advance written notice to the other.

# **Article 8: Assignment**

Jamba shall not sell, transfer, convey, assign or permit the use of any of Jamba's rights or privileges granted under this Agreement, or delegate or subcontract its duties hereunder in whole or in part, to any other person, firm, corporation or other entity, without the prior written consent of Company, which Company may withhold in its absolute discretion.

- **10.1** Governing Law: This Agreement is made in, and is to be performed in the State of California, and shall, for all purposes be governed by the laws of that State.
- **10.2 Merger of Prior Agreement and Amendment:** This Agreement sets forth the entire agreement between the parties as to the subject matter herein and supersedes all prior correspondence, understandings or agreements, whether oral or written. This Agreement may only be amended by a written agreement signed by the parties hereto and specifically referring to this Agreement and rights contained thereunder shall not be waived unless in writing.
- **10.3 Severability:** If any provision of this Agreement shall be held invalid, illegal or unenforceable in any respect, the validity, legality and enforceability of all other provisions of this Agreement shall not be affected or impaired.

- **10.4 Authority:** Jamba represents and warrants that it is duly authorized to execute, deliver and perform this Agreement; that it has all requisite corporate authority, and has taken all necessary corporate action to enter into this Agreement and fulfill its obligations hereunder; and that the person signing this Agreement on behalf of Jamba is authorized to do so.
- **10.5 Attorneys' Fees:** If any suit, action or proceeding is instituted between Company and Jamba in connection with, or in any way arising out of, or relating to, the terms or covenants of this Agreement, the party prevailing in such action shall be entitled to recover from the nonprevailing party all of its costs of such suit, action or proceeding.

<u>Background:</u> As of 1996, a "Declaration of Need for Fully Qualified Educators" must be completed and

adopted yearly based on the anticipated need for the subsequent school year. This Declaration must be Board adopted and submitted to the Commission on Teacher

Credentialing before any alternate credentials may be processed.

The Fullerton School District has the following general needs that may be met through the emergency credential process:

• Classroom teachers to meet authorization for instruction to limited English proficient students per Williams Lawsuit in schools ranked in deciles 1-3.

- All core academic subject teachers to become NCLB compliant.
- Filling preschool, special education positions for which a specialist credential is required.
- Filling special education positions to allow these educators time to meet new requirements for special authorizations.
- Filling junior high positions for which qualified teachers are difficult to find, including but not limited to foreign language, science, math, English language learners.
- Obtaining certification for those teachers, who, because of scheduling needs, teach one or two periods outside their credentialed area, i.e., five periods of language arts and one period of physical education.
- Filling positions with teachers from out of state or private schools to allow these educators additional time to complete California credentialing requirements.

Rationale: The Board of Trustees is required to adopt the "Declaration of Need for Fully Qualified

Educators" at a public meeting certifying that there may be an insufficient number of certificated persons who meet the District's specific employment criteria for identified positions. The completed Declaration is filed with the Commission on Teacher

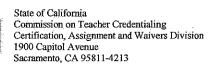

<u>Background:</u> At their meeting February 19, 2013, the Board of Trustees authorized the

The refinancing includes the bonds from the two CFDs that the District is part of: 2000-1 (Van Daele) and 2001-1 (Amerige Heights) and is using a Joint Powers Authority (JPA) to act as the legal entity that will perform the refinancing. Refinancing Bonds are being issued to pay off (defease) the existing special tax bonds, with the new special tax refunding bonds being

issued at a lower interest rate.

Rationale: Issuing the special tax refunding bonds will lower the interest rate and will

permit lower special tax rates to be charged.

Funding: Costs to refinance the bonds will come out of the refinancing proceeds. No

costs would be charged directly to the District.

Recommendation: Adopt Resolution #12/13-23 to authorize the issuance of its 2013 special tax

refunding bonds in a principal amount not to exceed \$1,500,000 and approving

certain documents and taking certain other actions in connection therewith.

WHEREAS, the Board of Trustees of Fullerton School District (the "School District"), located in Orange County, California (hereinafter sometimes referred to as the "legislative body of the District"), has heretofore undertaken proceedings to form Community Facilities District No. 2000-1 of the Fullerton School District (the "District"), pursuant to the terms and provisions of the Mello-Roos Community Facilities Act of 1982, as amended, being Chapter 2.5, Part 1, Division 2, Title 5 of the Government Code of the State of California (the "Act"); and

WHEREAS, the District has previously issued its \$1,195,000 Community Facilities District No. 2000-1 of the Fullerton School District Series 2001 Special Tax Bonds (the "Prior Bonds") to finance certain public improvements; and

WHEREAS, the legislative body of the District now desires to refund the Prior Bonds through the issuance of bonds in an aggregate principal amount not to exceed \$1,500,000 designated as the "Community Facilities District No. 2000-1 of the Fullerton School District 2013 Special Tax Refunding Bonds" (the "2013 Bonds"); and

WHEREAS, in order to effect the issuance of the 2013 Bonds, the legislative body of the District desires to enter into a Bond Indenture, dated as of June 1, 2013 (the "Local Obligation Bond Indenture"), with U.S. Bank National Association, as Fiscal Agent, in substantially the form presented herewith; and

WHEREAS, in order to effect the refunding and redemption of the Prior Bonds, the legislative body of the District desires to enter into an Escrow Agreement, dated as of June 1, 2013 (the "Escrow Agreement"), with U.S. Bank National Association, as Escrow Bank, in substantially the form presented herewith; and

WHEREAS, the legislative body of the District has determined in accordance with Section 53360.4 of the Code that a negotiated sale of the 2013 Bonds to the Fullerton School District Financing Authority (the "Authority") in accordance with the terms of the Local Obligations Purchase Agreement to be entered into by and among the Authority, the District and certain other community facilities districts named therein (the "Bond Purchase Agreement") approved as to form by this legislative body herein will result in a lower overall cost to the District than a public sale; and

WHEREAS, the legislative body of the District has determined that it is prudent in the management of its fiscal affairs to issue the 2013 Bonds; and

WHEREAS, the Authority will issue its bonds (the "Authority Bonds") to provide funds for its purchase of the 2013 Bonds;

NOW, THEREFORE, the Board of Trustees of the Fullerton School District (the "Board"), acting in its capacity as the legislative body of Community Facilities District No. 2000-1 of the Fullerton School District, hereby resolves as follows:

#### **Section 1.** Each of the above recitals is true and correct.

**Section 2.** The legislative body of the District is authorized pursuant to the Act to issue the 2013 Bonds for the benefit of the District for purposes set forth herein and to take the necessary steps to refund, defease and redeem the Prior Bonds.

Section 3. The issuance of the 2013 Bonds in an aggregate principal amount not to exceed \$1,500,000 is hereby authorized with the exact principal amount to be determined by the official signing the Bond Purchase Agreement in accordance with Section 6 below. The legislative body of the District hereby determines that it is prudent in the management of its fiscal affairs to issue the 2013 Bonds. The 2013 Bonds shall mature on the dates and pay interest at the rates set forth in the Bond Purchase Agreement to be executed by the District in accordance with Section 6 hereof. The 2013 Bonds shall be governed by the terms and conditions of the Local Obligation Bond Indenture. The Local Obligation Bond Indenture shall be prepared by Bond Counsel to the District and executed by any one of the President and the Clerk of the legislative body of the District, the Superintendent, and Assistant Superintendent, Business Services of the School District, or their written designees (collectively the "Authorized Officers"), acting alone, substantially in the form on file with the Secretary to the Board, with such additions thereto and changes therein as the Authorized Officer or Authorized Officers executing the same deem necessary to cure any ambiguity or defect therein, to insert the offering price(s), interest rate(s), selling compensation, principal amount per maturity, redemption dates and prices and such other related terms and provisions as limited by Section 6 hereof, to conform any provisions therein to the Bond Purchase Agreement and the Official Statement for the Authority Bonds and to conform to any requirements of any bond insurer selected by the Authority should the Authority determine to purchase municipal bond insurance. Approval of such changes shall be conclusively evidenced by the execution and delivery of the Local Obligation Bond Indenture by any one of the Authorized Officers, acting alone. Capitalized terms used in this Resolution which are not defined herein have the meanings ascribed to them in the Local Obligation Bond Indenture.

In satisfaction of the requirements contained in Section 53363.2 of the Act, the legislative body of the District hereby determines that: (1) it is anticipated that the purchase of the 2013 Bonds will occur on or about June 12, 2013, (2) the 2013 Bonds shall be dated their date of issuance, and be in the denominations, have the maturity dates (which do not exceed the latest maturity date of the Prior Bonds being refunded), and be payable at the place and be in the form specified in the Local Obligation Bond Indenture, (3) the 2013 Bonds will bear interest at the minimum rate of 0.5% per annum, and (4) the designated cost of issuing the 2013 Bonds being used to refund the Prior Bonds, as defined by Section 53363.8 of the Act, shall include all of the costs specified in Section 53363.8(a), (b)(2) and (c).

Consistent with Section 53364.2 of the Act, the legislative body of the District hereby determines that any savings achieved through the issuance of the 2013 Bonds shall be used to reduce special taxes of the District, and such reductions shall be made in accordance with the Act.

- **Section 4.** The 2013 Bonds shall be executed on behalf of the District by the manual or facsimile signature of the President of the legislative body of the District and attested with the manual or facsimile signature of the Clerk of the legislative body of the District. U.S. Bank National Association is hereby appointed to act as Fiscal Agent for the 2013 Bonds.
- **Section 5.** The covenants set forth in the Local Obligation Bond Indenture to be executed in accordance with Section 3 above are hereby approved, shall be deemed to be covenants of the Board in its capacity as the legislative body of the District and shall be complied with by the District and its officers.
- **Section 6.** The form of the Bond Purchase Agreement on file with the Secretary to the Board is hereby approved; and any one of the Authorized Officers, acting alone, is hereby authorized and directed, for and in the name of the District, to execute, and the Clerk, or his written designee, is authorized to attest to, the Bond Purchase Agreement substantially in the form approved, with such additions thereto and changes therein as may be approved or required by an Authorized Officer, including changes relating to dates and numbers as are necessary to conform the Bond Purchase Agreement to the dates, amounts and interest rates applicable to the 2013 Bonds as of the sale date. Approval of such additions and changes shall be conclusively evidenced by the execution and delivery of the Bond Purchase Agreement; provided, however, that the Bond Purchase Agreement shall be signed only if the principal and total interest cost to maturity on the 2013 Bonds is less than the principal and total interest cost to maturity on the Prior Bonds and the last maturity date of the 2013 Bonds is not later than the last maturity date of the Prior Bonds.
- **Section 7.** The form of the Escrow Agreement on file with the Secretary to the Board is hereby approved; and any one of the Authorized Officers, acting alone, is hereby authorized and directed, for and in the name of the District, to execute the Escrow Agreement, with such additions thereto and changes therein as may be approved or required by an Authorized Officer, including changes to conform to the final pricing of the escrow investments and to clarify any ambiguities; provided that the form of Escrow Agreement may be modified to conform to federal tax law requirements or to achieve further savings, with the advice and assistance of Bond Counsel, such approval to be conclusively evidenced by the execution of the Escrow Agreement by an Authorized Officer. U.S. Bank National Association is hereby appointed to act as Escrow Agent under the Escrow Agreement.
- **Section 8.** In accordance with the requirements of Section 53345.8 of the Act, the legislative body of the District hereby determines that the value of the real property in the District subject to the special tax to pay debt service on the 2013 Bonds is at least three times the principal amount of the 2013 Bonds and the principal amount of all other bonds outstanding that are secured by a special tax levied pursuant to the Act or a special assessment levied on property within the District.
- **Section 9.** Each of the Superintendent and Assistant Superintendent, Business Services of the School District, or their written designees, acting alone, is authorized to provide for all services necessary to effect the issuance of the 2013 Bonds. Such services shall include, but not be limited to, obtaining legal services, fiscal agent services, special tax consultant services and any other services deemed appropriate. Each of the foregoing officers, acting alone, is authorized to pay for the cost of such services, together with other costs of issuance from 2013 Bond proceeds or other funds of the District.

**Section 10.** The President and Clerk of the legislative body of the District and the other officers and staff of the School District and the District responsible for the fiscal affairs of the District are hereby authorized and directed to take any actions and execute and deliver any and all documents as are necessary to accomplish the issuance, sale and delivery of the 2013 Bonds in accordance with the provisions of this Resolution and the fulfillment of the purposes of the 2013 Bonds as described in the Local Obligation Bond Indenture. In the event that the President of the legislative body of the District is unavailable to sign any document authorized for execution herein, any other member of the legislative body of the District may sign such document. Any document authorized herein to be signed by the Clerk of the legislative body of the District may be signed by a duly appointed deputy Clerk.

<u>Background:</u> At their meeting February 19, 2013, the Board of Trustees authorized the

Superintendent to proceed with refinancing of the District's two Community

Facilities Districts' (CFD) bonds.

The refinancing includes the bonds from the two CFDs that the District is part of: 2000-1 (Van Daele) and 2001-1 (Amerige Heights) and is using the

Fullerton School District Financing Authority, a Joint Powers Authority (JPA) to act as the legal entity that will perform the refinancing. Refinancing Bonds are being issued to pay off (defease) the existing special tax bonds, with the new

special tax refunding bonds being issued at a lower interest rate.

Rationale: Issuing the special tax refunding bonds will lower the interest rate and will

permit lower special tax rates to be charged.

<u>Funding:</u> Costs to refinance the bonds will come out of the refinancing proceeds. No

costs would be charged directly to the District.

Recommendation: Adopt Resolution #12/13-25 to authorize the issuance of its special tax revenue

refunding bonds in one or more series, in an aggregate principal amount not to exceed \$18,500,000 and approving certain documents and taking certain other

actions in connection therewith.

#### **RESOLUTION #12/13-25**

RESOLUTION OF THE BOARD OF DIRECTORS OF THE FULLERTON SCHOOL DISTRICT FINANCING AUTHORITY, ORANGE COUNTY, CALIFORNIA, AUTHORIZING THE ISSUANCE OF ITS SPECIAL TAX REVENUE REFUNDING BONDS IN ONE OR MORE SERIES, IN AN AGGREGATE PRINCIPAL AMOUNT NOT TO EXCEED \$18,500,000 AND APPROVING CERTAIN DOCUMENTS AND TAKING CERTAIN OTHER ACTIONS IN CONNECTION THEREWITH

WHEREAS, the Fullerton School District Financing Authority (the "Authority") is a joint exercise of powers authority duly organized and existing under the provisions of Articles 1 through 4 (commencing with Section 6500) of Chapter 5 of Division 7 of Title 1 of the Government Code of the State of California (the "Act"), and is authorized pursuant to Article 4 of the Act (the "Bond Law") to borrow money for the purpose of financing the acquisition of bonds, notes and other obligations to provide financing and refinancing for capital improvements of member entities of the Authority and other local agencies; and

WHEREAS, Community Facilities District No. 2000-1 of the Fullerton School District ("CFD No. 2000-1") previously issued the \$1,195,000 Community Facilities District No. 2000-1 of the Fullerton School District Series 2001 Special Tax Bonds (the "Prior CFD No. 2000-1 Bonds") to finance certain public improvements; and

WHEREAS, Community Facilities District No. 2001-1 of the Fullerton School District ("CFD No. 2001-1") previously issued the \$19,450,000 Community Facilities District No. 2001-1 of the Fullerton School District Series 2001 Special Tax Bonds (the "Prior CFD No. 2001-1 Bonds" and, together with the Prior CFD No. 2000-1 Bonds, the "Prior CFD Bonds") to finance certain public improvements; and

WHEREAS, as a result of favorable conditions in the municipal bond market, each of the Community Facilities Districts desires to defease and refund its Prior CFD Bonds; and

WHEREAS, the Authority, for the purpose of acquiring special tax refunding bonds of each of the Community Facilities Districts (the "Local Obligations"), the proceeds of which will be utilized to defease and refund the Prior CFD Bonds, has determined to issue its Special Tax Revenue Refunding Bonds 2013 Series A (Senior Lien Bonds) and its Special Tax Revenue Refunding Bonds 2013 Series B (Junior Lien Bonds) (each a "Series" and, together, the "2013 Authority Bonds") pursuant to and secured by an Indenture (as defined below) providing for the issuance of the 2013 Authority Bonds, all in the manner provided therein; and

WHEREAS, the 2013 Authority Bonds will be secured by debt service payments paid with respect to the Local Obligations, the payment of which will be secured special tax liens on taxable property within the respective Community Facilities Districts or Improvement Areas therein, as applicable; and

WHEREAS, for this refinancing there has been filed with the Executive Director of the Authority the forms of the following documents to be executed or delivered by the Authority with

respect to the issuance of the 2013 Authority Bonds, which documents the Board desires to approve for execution as described herein:

- (1) The Indenture of Trust, dated as of June 1, 2013 (the "Indenture"), by and between the Authority and U.S. Bank National Association, as Trustee;
- (2) The Preliminary Official Statement for the 2013 Authority Bonds (the "Preliminary Official Statement");
- (3) The Bond Purchase Agreement, to be dated the date of sale, by and between Piper Jaffray & Co. (the "Underwriter") and the Authority (the "Bond Purchase Agreement");
- (4) The Local Obligations Bond Purchase Agreement, to be dated the date of sale, by and among the Authority and the Community Facilities Districts (the "Local Bond Purchase Agreement"); and
- (5) The Continuing Disclosure Agreement dated as of June 1, 2013, by and between the Authority and Dolinka Group, LLC, as Dissemination Agent; and

WHEREAS, the Board of Trustees of the Fullerton School District has determined that the issuance of the 2013 Authority Bonds and the acquisition of the Local Obligations will result in significant public benefits of the type described in Section 6586 of the Bond Law;

NOW, THEREFORE, the Board of Directors of the Fullerton School District Financing Authority DOES HEREBY RESOLVE, ORDER AND DETERMINE AS FOLLOWS:

<u>SECTION 1.</u> Each of the above recitals is true and correct and is adopted by the Board of Directors.

SECTION 2. The 2013 Authority Bonds shall be issued in an aggregate principal amount not to exceed \$18,500,000 with the exact principal amount of each Series to be determined by the official signing the Bond Purchase Agreement in accordance with Section 4 below. The 2013 Authority Bonds shall mature on the dates and pay interest at the rates set forth in the Bond Purchase Agreement to be executed on behalf of the Authority in accordance with Section 4 below. The 2013 Authority Bonds shall be issued under the terms of the Indenture, the form of which is on file with the Executive Director of the Authority. The form of the Indenture on file with the Executive Director of the Authority is hereby approved and each of the President of the Board of Directors, the Executive Director, the Clerk and the Director of Finance of the Authority (appointed pursuant to Section 8 hereof), or their respective written designees (collectively, the "Authorized Officers"), acting alone, is hereby authorized to execute the Indenture, in the form hereby approved, with such additions thereto and changes therein as the Authorized Officer or Authorized Officers executing the same deem necessary to accomplish the issuance of the 2013 Authority Bonds as contemplated by this Resolution. Approval of such changes shall be conclusively evidenced by the execution and delivery of the Indenture by one or more of such Authorized Officers.

<u>SECTION 3.</u> The 2013 Authority Bonds shall be executed on behalf of the Authority by the manual or facsimile signature of the President of the Board of Directors and attested with the manual or facsimile signature of the Clerk of the Board of Directors. U.S. Bank National Association is hereby appointed to act as the trustee for the 2013 Authority Bonds under the Indenture. If the

Executive Director determines at any time while the 2013 Authority Bonds are outstanding that another bank should be selected to act as trustee for the 2013 Authority Bonds, in order to ensure the efficient administration of the 2013 Authority Bonds, then the Executive Director, or his designee, is hereby authorized and directed to select and engage a bank or trust company meeting the requirements set forth in the Indenture to act as the trustee for the 2013 Authority Bonds under the terms of the Indenture.

SECTION 4. The form of the Bond Purchase Agreement on file with the Executive Director of the Authority is hereby approved; and each of the Authorized Officers, acting alone, is hereby authorized to execute the Bond Purchase Agreement in the form so approved, with such additions thereto and changes therein as are necessary to conform the Bond Purchase Agreement to the dates, amounts and interest rates applicable to the 2013 Authority Bonds as of the sale date or to cure any defect or ambiguity therein. Approval of such additions and changes shall be conclusively evidenced by the execution and delivery of the Bond Purchase Agreement by one or more of such Authorized Officers; provided, however, that the Bond Purchase Agreement shall be signed only if the Underwriter's discount (exclusive of original issue discount) does not exceed 1.25% of the principal amount of the 2013 Authority Bonds. Each of the Executive Director, the Clerk, the Director of Finance and their written designees, acting alone, is authorized to determine the day on which the 2013 Authority Bonds are to be priced in order to attempt to produce the lowest borrowing cost for the Authority and may reject any terms presented by the Underwriter to the Authority if determined not to be in the best interest of the Authority.

In the event that any one of the Executive Director, the Clerk, the Director of Finance, or their written designees, acting alone, determines that the purchase of one or more of the Local Obligations will not result in sufficient net present value savings to a Community Facilities District or will not otherwise achieve the purposes of the Authority set forth in this Resolution, then the Local Obligations of such Community Facilities District or Improvement Area therein, as applicable, will not be purchased by the Authority, and the Authority Documents may be amended to reflect that such Local Obligations will not be purchased by the Authority.

Each of the Authorized Officers, acting alone, is hereby authorized to negotiate the terms of a commitment (the "Insurance Commitment") for bond insurance from one or more municipal bond insurance companies (an "Insurer") and, if such officer determines that the acquisition of a policy from an Insurer will result in net interest rate savings, to pay the insurance premium of for such policy from the proceeds of the 2013 Authority Bonds and to amend the Authority Documents to the extent necessary to conform to the terms of the Insurance Commitment.

SECTION 5. The form of the Local Bond Purchase Agreement on file with the Executive Director of the Authority is hereby approved; and each of the Authorized Officers, acting alone, is hereby authorized to execute the Local Bond Purchase Agreement in the form so approved, with such additions thereto and changes therein as are necessary to conform the Local Bond Purchase Agreement to the dates, amounts and interest rates applicable to the Local Obligations as of the sale date or to cure any defect or ambiguity therein. Approval of such additions and changes shall be conclusively evidenced by the execution and delivery of the Local Bond Purchase Agreement by one or more of such Authorized Officers.

<u>SECTION 6.</u> The form of the Continuing Disclosure Agreement on file with the Executive Director of the Authority is hereby approved; and each of the Authorized Officers, acting alone, is authorized to execute the Continuing Disclosure Agreement in the form so approved, with such

additions thereto and changes therein as the officers executing the same deem necessary to comply with the requirements of Rule 15c2-12 of the Securities and Exchange Commission and to cure any ambiguity or defect therein. Approval of such changes shall be conclusively evidenced by the execution and delivery of the Continuing Disclosure Agreement by one or more of such Authorized Officers.

SECTION 7. The form of the Preliminary Official Statement on file with the Executive Director of the Authority is hereby approved; and the Underwriter is hereby authorized to distribute the Preliminary Official Statement to prospective purchasers of the 2013 Authority Bonds in the form hereby approved, together with such additions thereto and changes therein as are determined necessary by the Executive Director or the Director of Finance of the Authority, or their written designees, to make such Preliminary Official Statement final as of its date for purposes of Rule 15c2-12 of the Securities and Exchange Commission, including, but not limited to, such additions and changes as are necessary to make the information therein accurate and not misleading. Each of the Authorized Officers is hereby authorized to deliver a final Official Statement in the form of the Preliminary Official Statement, together with such changes as are determined necessary by the Executive Director or the Director of Finance of the Authority, or their written designees, to make such Official Statement complete and accurate as of its date. The Underwriter is further authorized to distribute the final Official Statement for the 2013 Authority Bonds, and any supplement thereto, to the purchasers of the 2013 Authority Bonds upon its delivery to the Underwriter by the Authority as described above.

<u>SECTION 8.</u> Pursuant to Section 4(D)(4) of the Joint Exercise of Power Agreement by and between the Fullerton School District and CFD No. 2000-1, dated as of April 1, 2013, the Board hereby appoints the Assistant Superintendent, Business Services, of the School District to serve as the Director of Finance of the Authority.

<u>SECTION 9.</u> The Authorized Officers are hereby appointed as the authorized officers of the Authority for all purposes required to effect the issuance of the 2013 Authority Bonds and are hereby authorized, empowered, and directed, jointly and severally, to do all such acts and things and to execute all such documents as may be necessary to carry out and comply with the foregoing actions.

SECTION 10. Stradling Yocca Carlson & Rauth, a Professional Corporation ("SYCR") shall act as bond counsel with respect to the issuance of the 2013 Authority Bonds and the Local Obligations to be issued simultaneously with the issuance of the 2013 Authority Bonds. Each of the Authorized Officers, acting alone, is authorized to execute an agreement with SYCR to act as bond counsel and to pay for the cost of such services, together with other Costs of Issuance (as defined in the Indenture), with proceeds of the 2013 Authority Bonds or other funds of the Community Facilities Districts deposited pursuant to the Indenture.

SECTION 11. Dolinka Group, LLC, ("Dolinka Group") shall act as special tax consultant and dissemination agent in connection with the issuance of the 2013 Authority Bonds and the Local Obligations. Each of the Authorized Officers, acting alone, is authorized to execute an agreement with Dolinka Group to serve as special tax consultant and to pay for the cost of such services as one of the Costs of Issuance (as defined in the Indenture), with proceeds of the 2013 Authority Bonds or other funds of the Community Facilities Districts deposited pursuant to the Indenture.

SECTION 12. The Authorized Officers are hereby authorized and directed, to do any and all things and to execute and deliver any and all documents which they may deem necessary or advisable in order to consummate the issuance and sale of the 2013 Authority Bonds and the defeasance and refunding of the Prior CFD Bonds and otherwise to effectuate the purposes of this Resolution.
