Background:	Assembly Bill 1X (Chapter 4, Statues of 1999) established the California Peer Assistance and Review (PAR) program which allows exemplary teachers to assist veteran teachers who need to develop their subject matter knowledge, teaching strategies, or both. On June 13, 2000, the Board approved Fullerton School District's participation in the PAR program.
	One of the provisions of the program is the establishment of a Joint Panel comprised of four (4) teachers, and three (3) school administrators. The Coordinator of Curriculum and Staff Development oversees the program (Section 2: Joint Panel-Peer Assistance and Review Agreement). The Board recessed into Closed Session at 4:08 p.m. for: •Conference with District's Chief Negotiator regarding FETA (Fullerton Elementary Teachers Association) and CSEA (California School Employees Association); District Representative – Mr. Mark Douglas [Government Code sections 54954.5(f), 54957.6]; •Public Employee Discipline, Dismissal, Release, and Personnel Matters [Government Code sections 54954.5(d), 54957]; •Potential Litigation [Government Code section 54956.9(b)(1)] – Dr. Cameron M. McCune

Call to Order, Pledge of Allegiance, and Report from Closed Session

The Board returned to Open Session at 5:31 p.m., and Boy Scout Pack #1238 from Fisler School led the Pledge of Allegiance to the flag. President Ballard presented the Scouts with Certificates. President Ballard reported from Closed Session that the Board approved the Final Settlement and Release between the Fullerton School District and the parents of special education student (MIS ID#95-00200) for reimbursement of nonpublic school tuition, assessments and attorney fees in the amount of \$1,000.00. Mrs. Ballard also reported the Board reviewed a request for a stipulated expulsion concerning case #040501, and it was

moved, seconded by Minard Duncan and carried unanimously that the student be expelled from all the schools and programs of the District for the semester in which the act occurred and the following semester. The Board finds that the student has violated Education Code sections 48900.2 and 48900(k). The Board further finds that due to the nature of the act, the presence of the pupil causes a continuing danger to the physical safety of the pupil or others. The student may reapply for readmission on or after the Spring semester of the 2005/2006 school year. It is moved that pursuant to California Education Code section 48916, a rehabilitation plan be developed by the Superintendent or designee and recommended to the student and the student's parents for completion during the period of expulsion. Readmission to the District at the end of the expulsion period will be contingent upon satisfactory completion of the rehabilitation plan.

Introductions/Recognitions

President Ballard spoke about the school bus accident in which District bus driver Sailasa Nava calmly and heroically handled what could have been a very tragic accident. Transportation Director Mike Brito described in detail and showed photographs of the March 24, 2005 accident and also spoke about District bus driver Nina Wilson's (bus that was behind Mr. Nava's bus) calmness and assistance that afternoon. Principal Harriet Hermann thanked Fern Drive teachers Eileen Hansen, Debbie Ronstadt, Kerri White, and Kelley Stewart for their help that day as well. Kevin Hobby presented the bus drivers and the teachers with plaques from ASCIP, and President Ballard presented them with Certificates. Richman Principal David Miyashiro and teachers Cliff Rosa, Karen Skoug, and Sharon Quirk honored 4-year volunteer Grandpa Burnie Cohen for always being there to help and interact with students. Mr. Cohen reads to kindergarten, first, second, and third grade students. PTA President Beverly Berryman presented the annual PTA Reflections Contest Award of Merit to Golden Hill student Vivian Liu for her musical composition, and Trustee Sugarman commented that over 768,000 students in the County compete in the Reflections Contest, so this is quite an honor. Mrs. Berryman also thanked Laurice Singer for her many years of involvement and assistance regarding the PTA Reflections Contest.

Superintendent's Report

Dr. McCune congratulated this evening's honorees: Sailasa Nava, Eileen Hansen, Debbie Ronstadt, Burnie Cohen, Vivan Liu, and Laurice Singer. Superintendent McCune reported: the District has an audio tape copy of Board President Ellen Ballard and Beechwood School Principal Sue Faassen's lip-sync of "Wild Thing"; he was "jailed" for Muscular Dystrophy and thanked those who paid to get him out of jail; the American Red Cross Blood Drive on March 31 collected 27 pints of blood; sixteen students from Ladera Vista Junior High Language Arts teachers John MacMurray and Jennifer Maloney won amethysts and garnets for their mothers in the local contest "Why Mom Deserves a Diamond"; the District obtained some good ideas from the recent visit to a Culver City School District Middle School regarding scheduling, programs, and curriculum; attended the National School Boards Association Conference in San Diego; the Laptop 1:1 Program VIP Tour was well attended, and two of the visiting districts are starting up a similar program; thanked Nicolas Junior High School, Hermosa Drive School, and Robert C. Fisler School staffs for doing a superb job with the laptop "cutting edge" program; congratulated Acacia School teacher Naomi Jue, recipient of the Project Tomorrow Vision for Excellence Award; commented the quality of the Classified newsletter is outstanding.

Information from the Board of Trustees

Trustee Sugarman commented that regarding her recent attendance at the National School Boards Association Conference, every state has standards, and regardless of how much funding a district receives, the central focus is from the government. Mrs. Sugarman stated she was pleased to see 25 seniors in a third grade classroom at Hermosa Drive School learning how to handle laptop computers from the students. Trustee Sugarman thanked Superintendent McCune for bringing the District into the "laptop age" noting that visitors at the laptop tours are very pleased with what the Board and leadership have done to accomplish this, and community businesses are interested in partnering with the District. In addition to Dr. McCune, Mrs. Sugarman also thanked the curriculum, information services, and financial departments, as well as teachers. Trustee Sugarman stated she appreciates what the Assistance League does for the students noting that this year they have clothed over 1,300 students. Trustee Thornley acknowledged this week is Secretary week and noted the school secretaries really "run the schools". Mrs. Thornley stated May 11 is the Day of the Teacher, May 12 is Day of the School Nurse, and Week of the Classified Emloyee is May 16 through 22. Trustee Thornley congratulated the High School District noting that that three of the high schools have been designated as California Distinguished Schools. Trustee Bass stated that with the high schools receiving this honor, this is evidence that the Fullerton "education community" has dedicated teachers, faculty, students, and residents. Trustee Duncan stated he enjoyed the Valencia Park School Gold Rush Days. Mr. Duncan reported he attended the Science Advocacy Council meeting and he visited Science on the Go at Sunset Lane School. Trustee Duncan commented there has been confusion regarding the State budget, and many people are unaware that \$2 billion has been taken away from schools every year. President Ballard stated the Education Foundation donated \$16,000 to the District for hands-on science projects to be used in the classrooms, and the Foundation is sponsoring the annual Putting Tournament on Friday, May 20 at 4:00 p.m. at Golf Center on Harbor Boulevard.

Information from PTA, FETA, CSEA, FESMA

PTA Council President Beverly Berryman reminded the Board Members and Principals about the scholarships available for continuing education and asked that they encourage teachers to apply. Mrs. Berryman stated that this year, for the first time, four District teachers (two from Beechwood, one from Sunset Lane, and one from Acacia) were awarded educational grants. Mrs. Berryman invited Board Members and Dr. McCune to the annual PTA Installation Luncheon on May 24 at Muckenthaler Center, 11:00 a.m.

FETA President Barbara Moore stated Proposition 98 works and that the District's schools need it. Mrs. Moore commented that the Governor is not supporting this Proposition and that there will no longer be minimal funding to students. Mrs. Moore asked that no one sign any initiatives the Governor presents, and on May 3 there will be a rally at 4:00 p.m. on Harbor Boulevard between Chapman and Commonwealth, with everyone wearing orange-colored clothing. Mrs. Moore stated that Action Day is Wednesday, May 25 in Sacramento and Los Angeles. Mrs. Moore reported there is a Tentative Agreement between the District and the Fullerton Elementary Teachers Association, and voting will take place on Monday. Board President Ellen Ballard thanked the Negotiation Team and commented they did an excellent job as well as the District Team headed by Mark Douglas.
